**SPECIAL ORDER**

**Williams Fork Fire**

Pursuant to Title 16 U.S.C. § 551, and Title 36, Code of Federal Regulations (CFR), § 261.50 (a) and (b), the following acts are prohibited on National Forest System lands, trails and roads described below, located in the vicinity of the Williams Fork Fire. Upon signature of this document, Order # ARP-SRD-2020-06 is rescinded.

**PROHIBITIONS:**

Being in the areas described below. 36 CFR 261.52(e).

Being on the Roads described below. 36 CFR 261.54(e).

Being on the Trails described below. 36 CFR 261.55(a).

**EXEMPTIONS:**

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this Order:

1. Any Federal, State or local officer, or member of an organized rescue or firefighting force in the performance of an official duty;
2. Persons with a Forest Service permit specifically exempting them from the effect of this Order.

**AREAS, ROADS, AND TRAILS DESCRIBED:**

**National Forest System Roads:** 132, 136, 138, 138.2, 139 (from Co. Rd. 30 to junction with 136), 139.3, 140, 140.3, 141.1, 142.1, 144.1, 155, 136.1A, 138.1B, 138.1C, 138.1F, 138.1G, 138.2A.

**National Forest System Trails:** N12 (Byers Peak, N14.1 (St. Louis Pass), N15 (Lake Evelyn), N16 (Bottle Pass), N16.1 (Bottle Peak), N17.1 (B & B), N17 (St. Louis Divide), N18 (Darling Creek), N19 (Keyser Ridge), N21 (South Fork), N22 (Kinney Creek), N23 (Horseshoe Lake), N96 (Jones Pass), M140 (Keyser Ridge Loop), M141 (Elk Wallow), M142 (K&K Connection), M145 (Richey), and M146 (No-See-Um).

**Trailheads:** Williams Fork, Darling Creek, Ute Peak, Lake Evelyn, Keyser Ridge, Jones Pass, and Kinney Creek.

**Campgrounds:** South Fork, Sugarloaf, and Horseshoe.

Violations of these prohibitions are punishable as a Class B misdemeanor by a fine of not more than \$5000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. (16 U.S.C. § 551 and 18 U.S.C §§ 3559 and 3571).

Located within the Sulphur Ranger District and Clear Creek Ranger District of the Arapaho National Forest, in Grand County and Clear Creek County, Colorado, and depicted and shown on the attached Map, hereby incorporated into this Order as Exhibit A, located on the lands described below.

This Order goes into effect when signed and shall remain in effect until October 15, 2020 or until rescinded, whichever occurs first.
