Temporary Area Closure
Public Health and Safety***

Pursuant to 16 USC 551 and Title 36 Code of Federal Regulations, Section 261.55(a) the following acts are prohibited in the "Restricted Area" described in this Order, which are depicted on the attached Map, hereby incorporated into this Order as Exhibit A, all within the Clifton Ranger District, Apache-Sitgreaves National Forests, Greenlee County, Arizona:

PROHIBITIONS:

1. **Being on a Trail. 36 CFR 261.55(a)**

EXEMPTIONS:

Pursuant to 36 CFR 261.55(a) the following persons are exempt from this order:

1. Persons with a Forest Service permit specifically exempting them from the effect of this Order.
2. Any Federal, State, or Local law enforcement officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Owners or lessees of land within the Area.

RESTRICTED AREA DESCRIBED:

All National Forest System trails described below and depicted on the attached Exhibit A.

The restricted area includes National Forest System trails described as follows: A portion of Forest Service Trail 25 (Red Mountain Trail) beginning at the junction with Forest Service Trail 32 (Bear Pen Springs Trail) located in T1N, R29E, Section 17, traveling East to the trail termini.

PURPOSE:

The purpose of the temporary area closure is for the following purposes:

To assure the protection of public health and safety in the Closure Area during the Bringham Fire activities.

IMPLEMENTATION:

1. This Order shall be in effect when signed and shall remain in effect until August 14, 2021 or until it is rescinded, whichever is earlier.

3. Any violation of these prohibitions is punishable by a fine of not more than \$5,000.00 for individuals and \$10,000.00 for organizations, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581 (b) (7)].

5. This Order supersedes any previous Orders prohibiting the same acts covered by this Order


