On 08/31/2020, at 11:00 AM, sealed bids will be opened in the PNF Supervisor's Office, 159 Lawrence Street, Quincy, CA 95971 for the Hungry Fire Salvage SBA sale. This sale is located in T.27N, R.12E, section 33; T.26N, R.12E, sections 5, 4, 8, 9, 10, 15, 16, 17, 18, 20, 21, 22, 28, 29, 32, 33, and 34; and T.25N, R.12E, sections 2, 3, 4, 5, 8, 9, 10, 11, 13, and 14; Mt. Diablo Meridian, On the Mt Hough RD.. Timber sale Contract 2400-6 will be used. The termination date for this sale is 10/31/2021. This is a small business set-aside sale.

This sale will be preferentially awarded to a qualified small business concern. In the absence of any bids from a self-certifying qualified small business concern, the sale will be readvertised without restriction on the size of bidders.

Measurement of the estimated quantities will be made after felling. The total estimated quantity on this sale is 11,913.40 MBF. The Forest Service encourages potential bidders to make their own inspection and estimate prior to bid submission.
