UINTA-WASATCH-CACHE NATIONAL FOREST  
SALT LAKE RANGER DISTRICT

**TEMPORARY PARKING LOT AND TRAILHEAD CLOSURE**

**PROHIBITION:**

Pursuant to 36 CFR 261.50(a) and 36 CFR 261.50(b), **the following acts are prohibited** on the National Forest System parking lot and trailhead described in this order. The parking lot and trailhead affected are located on the Salt Lake Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect starting August 26, 2020 through November 30, 2020 or until rescinded.

1. **Being in or upon** the Grit Mill parking area/lot as described below and shown on attached map. This includes all pedestrian, hikers, bikers. [36 CFR 261.53(e)]
2. **Being in or upon** the Grit Mill trailhead as described below and shown on attached map. This includes all pedestrian, hikers, bikers. [36 CFR 261.53(e)]

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this order.
2. Any Federal, state or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

**AREA DESCRIPTION:**

The closures includes the Grit Mill parking lot and trailhead located approximately ½ mile (east) up the road from the Park and Ride parking area at the bottom of the Little Cottonwood Canyon, (Utah State Highway 210), on the north side of the highway located in Township 3 South, Range 2 East, Section 7, all within the Salt Lake Base Meridian. As shown on the attached map.

**PURPOSE:**

The area is closed for public health and safety while construction crews and equipment are constructing a new parking lot. The project is to increase the availability of designated parking areas, this project will provide 32 parking stalls, 2 handicap parking stalls and a restroom facility.

**IMPLEMENTATION:**

1. This Order will be in effect when signed August 26, 2020 and shall remain in effect until November 30, 2020 or until rescinded.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the area covered by this Order.
