SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
LOGAN RANGER DISTRICT

ROAD CLOSURES

PROHIBITION:

Pursuant to 36 CFR 261.50(a) and 36 CFR 261.50(b), **the following acts are prohibited** on the National Forest System road described in this order. The area affected road located within the Logan Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect September 21, 2020 until October 2, 2020 or until rescinded

1. **Being in or upon the** Left Hand Fork road (Forest Service road #245), This includes any type of motorized vehicle, all pedestrian, equestrian and bicycle use as described below and shown on attached map.
[36 CFR 261.53(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this order.
2. Any Federal, state or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIPTION:

The Left Hand Fork road (Forest Service road #245) closure starts at Leatham Hollow road (Forest Service road #149), to the gate on the east end of the road at the junction with Saddle Creek road (Forest Service road #105). The gate at the junction with the Herd Hollow road (Forest Service road #047) will also be closed all located in Township 11 North, Range 2 East, Sections 24, 25, 34 and 35, Township 11 North, Range 3 East, Sections 20, 21, 29, and 30 all within the Salt Lake Base Meridian as shown on the attached map.

PURPOSE:

Purpose of the closure is for public health and safety while crews complete maintenance work on dispersed campsites along the road.

IMPLEMENTATION:

1. This Order will be in effect when signed September 21, 2020 and shall remain in effect until October 2, 2020 or until rescinded.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the area covered by this Order.
