ORDER NO. 06-10-20-20-12

EMERGENCY FIRE AREA CLOSURE – Slater and Devil Fires

Pursuant to 36 CFR § 261.50(a) and (b), the following act is prohibited within the Siskiyou Mountains Ranger District as described below and as depicted in map attached as Exhibit A, located within the Rogue River-Siskiyou National Forest from September 25, 2020 until December 15, 2020, unless rescinded sooner.

PROHIBITIONS:

1. Being upon a closed road. [36 CFR § 261.54 (e)]
2. Going into or being upon a closed area. [36 CFR § 261.52 (e)]
3. Being on a trail. [36 CFR § 261.55(a)]

REDUCTION OF CLOSURE AREA:

- 1) **Continued closure for public health and safety.** **[36 CFR § 261.53(e)]**
 - A. Beginning at the southern end of Applegate Lake north on Carberry Creek Rd (County Rd 777) becoming Forest Service Road (FSR) 10 to District Boundary;
 - B. thence westerly and southerly following the district boundary to FSR 1055;
 - C. thence northerly following FSR 1055 to FSR 1050;
 - D. thence follow FSR 1050 northwesterly to County Road 859;
 - E. thence northwesterly along County Road 859 along southern end of Applegate Lake.
- 2) **Forest System Road closures at the following junctions.**
 - A. FSR 1055 at its junction with FSR 1050 to the District Boundary
 - B. FSR 1040 at its junction with FSR 1050 to it's junction with FSR 1030
 - C. FSR 1035 at its junction with County Road 777 to it's junction with FSR 1040
 - D. FSR 1030 at its junction with County Road 777 to it's junction with FSR 1040
 - E. FSR 1015 at its junction with County Road 777 to it's junction with FSR 1020
 - F. FSR 1020 at its junction with County Road 777 to it's endpoint
 - G. FSR 1005 at its junction with County Road 777 to it's endpoint

EXEMPTIONS:

Pursuant to 36 CFR § 261.50 (e), the following persons are exempt from this Order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.

This prohibition is in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

Violations of this prohibition is punishable as a Class B Misdemeanor, by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC § 551; 18 USC § 3559 and 18 USC § 3571).
