# Red-Salmon Fire, Fox Fire, and Slater-Devil Fire Closure <br> Klamath National Forest Order No. 20-05-24 <br> Six Rivers National Forest Order No. 20-10-13 

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Ukonom, Salmon River, Happy Camp, and Oak Knoll Ranger Districts of the Klamath National Forest and the Lower Trinity and Orleans Ranger Districts of the Six Rivers National Forest. This Order is effective from October 1, 2020, through October 31, 2020.

1. Going into or being upon the following National Forest System lands:
a. All National Forest System lands within the Red-Salmon Fire Closure Area, as described in Exhibit A and shown on Exhibit B.
b. All National Forest System lands within the Fox Fire Closure Area, as described in Exhibit A and shown on Exhibit C.
c. National Forest System lands within the Slater-Devil Fire Closure Area, as described in Exhibit A and shown on Exhibit D.

2. Being on the following National Forest System roads:
a. All National Forest System roads within the Red-Salmon Fire Closure Area, as shown on Exhibit B.
b. All National Forest System roads within the Fox Fire Closure Area, as shown on Exhibit C.
c. All National Forest System roads within the Slater-Devil Fire Closure Area, as shown on Exhibit D.
d. Forest Road Nos. 39N29, 39N30, 08N03, 10N05, 10N01, 10N47, 15N27, $15 \mathrm{~N} 39,15 \mathrm{~N} 39 \mathrm{~B}$, and 15 N 40 .

3. Being on the following National Forest System trails:
a. All National Forest System trails within the Red Salmon Fire Closure Area, as shown on Exhibit B.
b. All National Forest System trails within the Fox Fire Closure Area, as shown on Exhibit C.
c. All National Forest System trails within the Slater-Devil Fire Closure Area, as shown on Exhibit D.

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Owners or lessees of land in the area, to the extent necessary to access their property.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than $\$ 5,000$ for an individual or $\$ 10,000$ for an organization, or imprisonment for not more than 6 months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

1. The boundary of the Red-Salmon Fire Closure Area begins at the intersection of Salmon River Road (Siskiyou County Road 2B01) and the Six Rivers National Forest and the Klamath National Forest boundary, then continues southeasterly along southwestern edge of the Salmon River Road to its intersection with Forest Road No. 39 (Grasshopper Picayune Road), then continues easterly along the northern edge of Forest Road No. 39 to its intersection with the eastern line of Section 9, Township 39 North, Range, 12 West, Mount Diablo Meridian, then continues south along the eastern lines of Sections 9, 16, 21,28 , and 33 to its intersection with Cecilville Road (Siskiyou County Road 1C02), then continues southerly along the western edge of the Cecilville Road to its intersection with the northern line of Section 27, Township 38 North, Range 12 West, Mount Diablo Meridian, then continues west along the northern edge of Section 27 to its intersection with Forest Trail No. 5476, then continues southwesterly along the eastern edge of Forest Trail No. 5476 until its intersection with the Klamath National Forest and the ShastaTrinity National Forest boundary, then continues northwesterly along the Klamath National Forest and the Shasta-Trinity National Forest boundary until its intersection with the southern edge of Section 15, Township 6 North, Range 6 East, Humboldt Meridian, then continues west along the southern edge of Section 15 to the southwest corner of Section 15, then continues north along the western edge of Section 15 to its intersection with Forest Road No. 06N03, then continues northerly along the western edge Forest Road No. 06N03 to its intersection with Forest Road No. 06N10, then continues northwesterly along the southwestern edge of Forest Road No. 06N10 to its intersection with Forest Road No. 07N04, then continues northwesterly along the southwestern edge of Forest Road No. 07N04 to its intersection with Cedar Creek, then continues northwesterly along the southwestern edge of Cedar Creek to its intersection with the southern line of Section 3, Township 7 North, Range 5 East, Humboldt Meridian, then continues west along the southern line of Section 3 to the southwest corner of Section 3, then continues north along the western line of Section 15 until its intersection with Forest Road No. 08N03, then continues northeasterly along the northwestern edge of Forest Road No. 08N03 to its intersection with the Six Rivers National Forest and the Hoopa Valley Reservation boundary, then continues northeasterly along the Six Rivers National Forest and the Hoopa Valley Reservation boundary and then along the Hoopa Valley Reservation boundary to its intersection with the southern edge of Section 34, Township 10 North, Range 5 East, Humboldt Meridian, then continues east along the southern edge of Section 34 to the southwestern corner of Section 35, then continues north along the western edge of Sections 35, 26, and 23 to the northwest corner of Section 23, then continues east along the northern edge of Sections 23 and 24 to its intersection with the Six Rivers National Forest and the Klamath National Forest boundary, then continues north along the Six Rivers National Forest and the Klamath National Forest boundary back to the starting point.
2. The boundary of the Fox Fire Closure Area begins at the intersection of the South Fork Road (Siskiyou County Road 2H002) and Forest Road No. 40N17, then continues southerly along the eastern edge of Forest Road No. 40 N 17 to its intersection with Forest Trail No. 5577, then continues southerly along the eastern edge of Forest Trail No. 5577 to its intersection with the Klamath National Forest and the Shasta-Trinity National Forest boundary, then continues westerly along the boundary to its intersection with Forest Trail No. 2000, then continues northwesterly along the southern edge of Forest Trail No. 2000 to its intersection with the Cecilville Road (Siskiyou County Road 1C02), then continues northerly along the eastern edge Cecilville Road to its intersection with South Fork Road, then continues easterly along the southern edge of South Fork Road back to the starting point.
3. The boundary of the Slater-Devil Fire Closure Area begins at the intersection of State Highway 96 and Clear Creek, then continues northwesterly along the southwestern edge of Clear Creek to its intersection with the southern line of Section 29, Township 17N, Range 5 East, Humboldt Meridian, then continues west along the southern edge of Sections 29 and 30 to the southwest corner of Section 30, then continues north along the western edge of Section 30 to its intersection with the Klamath National Forest and the Six Rivers National Forest boundary, then continues along the Klamath National Forest and the Six Rivers National Forest boundary to its intersection with the Klamath National Forest and the Rogue River-Siskiyou National Forest boundary, then continues westerly along the Klamath National Forest and the Rogue River-Siskiyou National Forest boundary to its intersection with Forest Road No. 48N20, then continues southerly along the eastern edge of Forest Road No. 48N20 to its intersection with Seiad Creek, then continues southwesterly along the southeastern edge of Seiad Creek to its intersection with State Highway 96, then continues westerly along northern edge of State Highway 96 back to the starting point.
