

FOREST ORDER NO. 02-20-37
CLEVELAND NATIONAL FOREST
HOLY FIRE CLOSURE

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety and protect natural resources, the following acts are prohibited within the Trabuco Ranger District of the Cleveland National Forest. This Order is effective from October 10, 2020 through October 9, 2021.

1. Going into or being upon National Forest System lands within the Holy Fire Closure Area, as described in Exhibit A and shown on Exhibit B.
36 C.F.R. § 261.52(e).

Being on any National Forest System road within the Holy Fire Closure Area, as shown on Exhibit B. 36 C.F.R. § 261.54(e).

Being on any National Forest System trail within the Holy Fire Closure Area, as shown on Exhibit B. 36 C.F.R. § 261.54(e).


Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
2. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5000 for an individual or \$10,000 for an organization or imprisonment for not more than six months, or both.
16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

EXHIBIT A

The boundary of the Holy Fire Closure Area begins at the intersection of North Main Divide Road (Forest Road No. 3S04) and the Santiago Peak entrance road (Forest Road No. 3S04c), in the northwest corner of Section 29, Township 5 South, Range 6 West, San Bernardino Base and Meridian (S.B.M.), then continues due south, excluding the Santiago Peak Communications Site, to its intersection with the southern boundary of Section 29, Township 5 South, Range 6 West, S.B.M., then continues west along the southern boundary of Section 29 to its intersection with the southwest corner of Section 29, Township 5 South, Range 6 West, S.B.M., then continues south along the western boundary of Section 32 to its intersection with the southwest corner of Section 32, Township 5 South, Range 6 West, S.B.M., then continues west along the southern boundary of Section 31, Township 5 South, Range 6 West, S.B.M., to its intersection with the Cleveland National Forest Boundary, then continues south along the Cleveland National Forest Boundary to its intersection with the southern boundary of Section 6, Township 6 South, Range 6 West, S.B.M., then continues east along the southern boundaries of Sections 6, 5, 4, 3, and 2, Township 6 South, Range 6 West, S.B.M., to its intersection with the southeast corner of Section 2, Township 6 South, Range 6 West, S.B.M., then continues south along the western boundary of Section 12, Township 6 South, Range 6 West, S.B.M., to its intersection with the northwest corner of the southwest quarter of the southwest quarter of Section 12, Township 6 South, Range 6 West, S.B.M., then continues east across the southern half of the southwest quarter of Section 12 to its intersection with the eastern boundary of Section 12, Township 6 South, Range 6 West, S.B.M., then continues north along the eastern border of Sections 12 and 1, Township 6 South, Range 6 West, and Section 36, Township 5 South, Range 6 West, S.B.M., to its intersection with the northeast corner of Section 36, Township 5 South, Range 6 West, S.B.M., then continues west along the northern border of Section 36, Township 5 South, Range 6 West, S.B.M., to its intersection with the northwest corner of Section 36, Township 5 South, Range 6 West, S.B.M., then continues north along the eastern border of Section 26, Township 5 South, Range 6 West, S.B.M., to its intersection with the northeast corner of Section 26, Township 5 South, Range 6 West, S.B.M., then continues west along the northern borders of Sections 26, 27, and 28, Township 5 South, Range 6 West, S.B.M., to its intersection with the northeast corner of Section 29, Township 5 South, Range 6 West, S.B.M., then continues north along the eastern border of Section 20, Township 5 South, Range 6 West, S.B.M., to the hairpin turn on North Main Divide Road (Forest Road No. 3S04), at its intersection with the eastern boundary of Section 20, Township 5 South, Range 6 West, S.B.M., at Survey Benchmark 4874, then continues west along the northern side of North Main Divide Road (Forest Road No. 3S04) back to the starting point.
