SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
PLEASANT GROVE RANGER DISTRICT

TEMPORARY ROAD CLOSURE

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following acts are prohibited** on the National Forest System road as described in this order. The road affected is located on the Pleasant Grove Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect starting October 17, 2020 through October 31, 2020 or until further notice.

1. **Being in or being upon** Forest Service road #027 as described below and shown on attached map. This includes all motorized vehicles, pedestrian, hikers, equestrians, and bikers. [36 CFR 261.53(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

Forest Service road #027 is closed at the Forest Service boundary going south to Rock Canyon campground located in Township 5 South, Range 2 East, Section 8 and 9, Township 6 South, Range 3 East, Sections 17, 16, 21, 22 and 27 all within the Salt Lake Based Meridian, as shown on attached map.

PURPOSE:

Purpose of the Closure is to provide for firefighter and public safety during fire suppression efforts of the Range fire.

IMPLEMENTATION:

1. This Order will be in effect when signed October 17, 2020 and shall remain in effect through October 31, 2020 or until further notice.
2. Attached map shows the roads affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].
