TEMPORARY TRAIL CLOSURE  
(For Public Safety)**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(b), the following act described in this Order is prohibited on the trail described in this Order and depicted on the attached map, hereby incorporated into this Order as Exhibit A, within the boundaries of the North Kaibab Ranger District of the Kaibab National Forest, Coconino County, Arizona (AZ):

**PROHIBITIONS:**

1. Being on the trail. **36 C.F.R. § 261.55(a).**

**EXEMPTIONS:**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with a written Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer or administrative personnel, or member of an organized rescue or fire fighting force in the performance of an official duty.

**RESTRICTED TRAIL:**

The following Forest Service trail section depicted in Exhibit A is closed as part of this Order:

- The section of the Arizona National Scenic Trail starting at Government Reservoir, between Sections 26, and Section 35, in Township 40 North, Range 2 East and continuing south for approximately 3.5 miles to its intersection with FR 249 in Section 14, in Township 39 North, Range 2 East


**PURPOSE**

To protect public health and safety from hazardous conditions resulting from the Mangum Fire.

## **IMPLEMENTATION**

1. This Order will be effective on October 21, 2020, at 6:00 a.m., and shall remain in effect until October 15, 2022, or until rescinded, whichever occurs first.
2. A map identifying the section of closed trail and its alternate route is attached and is made part of this Order as Exhibit A.
3. Any violation of this prohibition is punishable as a class B misdemeanor by a fine of not more than \$5,000 for an individual, or \$10,000 for an organization and/or imprisonment for not more than six (6) months or both (*see* 16 U.S.C. § 551, 18 U.S.C. § 3571(b)(6), 18 U.S.C. § 3581(b)(7)).
4. 5. This Order supersedes any previous Orders prohibiting the same acts covered by this Order.
