FOREST ORDER NO. 05-01-21-03 BOBCAT FIRE AREA, ROAD, AND TRAIL CLOSURE ANGELES NATIONAL FOREST

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to protect natural resources and provide for public safety, the following acts are prohibited within the Angeles National Forest. This Order is effective from March 3, 2021, through April 1, 2022.

- 1. Going into or being upon National Forest System lands within the Angeles National Forest or San Gabriel Mountains National Monument as described in Exhibit A and shown on Exhibit B. 36 C.F.R. § 261.52(e).
- 2. Being on any National Forest System road within the Angeles National Forest or San Gabriel Mountains National Monument as described in Exhibit A, shown on Exhibit B, and listed in Exhibit C. 36 C.F.R. § 261.54(e).
- 3. Being on any National Forest System trail within the Angeles National Forest or San Gabriel Mountains National Monument as described in Exhibit A, shown on Exhibit B, and listed in Exhibit C. 36 C.F.R. § 261.55(a).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- 3. Owners or lessees of land, to the extent necessary to access their land.
- 4. Permanent residents, to the extent necessary to access their permanent residences.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

Wilson Trail to the western edge of Section 9 of Township 1 North, Range 11 West, SBBM; then continues north along the section line to the northeast corner of Section 29 of Township 2 North, Range 11 West, SBBM; then continues west to its intersection with Mt. Wilson Road at the southwest corner of Section 19 of Township 1 North, Range 11 West, SBBM; then continues along the northern edge of Mt. Wilson Road to its intersection with Highway 2 (Angeles Crest Highway) in Section 14 of Township 2 North, Range 12 West, SBBM; then continues north along the northern edge of Highway 2 to the southwest corner of Section 7 of Township 2 North, Range 11 West, SBBM; then continues north along the western edge of Section 7 of Township 2 North, Range 11 West, SBBM, to its northwest corner; then continues east to the southwest corner of Section 3 of Township 2 North, Range 11 West, SBBM; then continues north to the northwest corner of Section 34 of Township 3 North, Range 11 West, SBBM; then continues east to Highway 2 in Section 34 of Township 3 North, Range 11 West, SBBM; then continues north along the western edge of Highway 2 to the intersection with the Northern Ridgeline of the San Gabriel Watershed boundary in section 26 of Township 3 North, Range 11 West, SBBM; then continues east along the ridgeline to the intersection with the Mt. Waterman Trail in section 22 of Township 3 North, Range 10 West, SBBM; then continues north along the Mt. Waterman Trail to its intersection with Highway 2 in Section 15 of Township 3 North, Range 10 West, SBBM; then continues west along Highway 2 to Section 13 of Township 3 North, Range 10 West, SBBM; then continues north to the northeast corner of Section 12 of Township 3 North, Range 10 West, SBBM; then continues west to the Pacific Crest Trail in Section 1 of Township 3 North, Range 10 West, SBBM; then continues north along the Pacific Crest Trail to Section 34 of Township 4 North, Range 11 West, SBBM; then continues north to the northeast corner of Section 33 of Township 4 North, Range 11 West, SBBM; then continues west to the southwest corner of Section 28 of Township 4 North, Range 11 West, SBBM; then continues north to the congressional boundary in the northwest corner of Section 28 of Township 5 North, Range 11 West, SBBM; then continues east to the northeast corner of Section 24 of Township 4 North, Range 9 West, SBBM; then continues south to the southeast corner of Section 25 of Township 4 North, Range 9 West, SBBM; then continues west to the northeast corner of Section 35 of Township 4 North, Range 9 West, SBBM; then continues south to Highway 2 in the southeast corner of Section 2 of Township 3 North, Range 9 West, SBBM; then continues south along Highway 2 to Section 16 of Township 3 North, Range 9 West, SBBM; then continues south to the ridgeline delineating the North Fork San Gabriel and Big Rock Creek watersheds in Section 16 of Township 3 North, Range 9 West, SBBM; then continues along the ridgeline west, turning south in Section 17 of Township 3 North, Range 9 West, SBBM; then continues south to its intersection with the eastern ridge of the Bear Creek watershed in Section 31 of Township 3 North, Range 9 West, SBBM; then continues south to the southeast corner of Section 6 of Township 2 North, Range 9 West, SBBM; then continues east to the northeast corner of Section 8 of Township 2 North, Range 9 West, SBBM; then continues south along Highway 39 (San Gabriel Canyon Road), back to the starting point as shown on Exhibit B.
