Forest Supervisor's Order

**Road/Trail Restrictions: Burnt Peak Fire**

Pursuant to 16 U.S.C. § 551, and 36 C.F.R. §§ 261.50(a) and 261.50(b), the following restriction is in effect on the Three Rivers Ranger District on the Kootenai National Forest, Lincoln County, Montana.

**PROHIBITION**

36 C.F.R. § 261.55- National Forest System Trail  
36 CFR § 261.55(a) Being on the trail.

36 C.F.R. § 261.54-National Forest System Road  
36 CFR § 261.54(e) Being on the road.

**PURPOSE**

This restriction is for public safety due to fire management activities related to the Burnt Peak Fire.

**ROAD and TRAIL CLOSED**

As depicted on the map attached as Exhibit A and hereby incorporated into this Order, it is prohibited to be on:

1. National Forest System Road 427 (Callahan Creek Road) from its beginning in the northeast quarter of Section 22, T31N, R34W to its terminus near the west section line of Section 18, T59N, R03E; and
2. National Forest System Trail 153 (Callahan Historic Trail) in Sections 13, 22, and 23, T31N, R34W.

**IMPLEMENTATION**

This order will be in effect from August 8, 2021 to December 31<sup>st</sup>, 2021 or until rescinded, whichever comes first.

**EXEMPTIONS**

Pursuant to 36 C.F.R. §261.50(e), the following are exempt from this Order:

1. Persons with a special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order. 36 C.F.R. § 261.50(e)(1).
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty. 36 C.F.R. § 261.50(e)(4)

**PENALTY**

Violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581).


