



VICINITY MAP


THE MANAGEMENT AREAS IDENTIFIED ON THIS MAP AND THE MANAGEMENT DIRECTION DEFINED IN THE FOREST PLAN APPLY TO NATIONAL FOREST SYSTEM LANDS ONLY. THEY DO NOT APPLY TO ANY LANDS IN STATE, PRIVATE, OR OTHER OWNERSHIP.

MANAGEMENT AREAS

Management areas are groupings of capability areas which will be managed with a particular emphasis through application of a specific combination of multiple-use practices. The management emphasis or the area to which an emphasis applies may vary between alternatives.

- 1B-1** MANAGEMENT AREA 1B-1 - Provides for existing winter sports sites, recreation opportunities focus on downhill skiing during the winter and on dispersed recreation during the rest of the year. Cross country skiing may occur.
- 1B-2** MANAGEMENT AREA 1B-2 - Provides for potential winter sports sites. Sites are maintained for future downhill skiing recreation opportunities. The area is a natural appearing forest with subtle vegetation changes. Recreation opportunities focus on dispersed recreation uses.
- 1D** MANAGEMENT AREA 1D - Management emphasis is for major oil and gas pipelines, major water transportation and slurry pipelines, electrical transmission lines, and transcontinental telephone lines. Activities within these corridors and sites will be compatible with the adjacent management area direction.
- 2A** MANAGEMENT AREA 2A - Provides opportunity for outdoor recreation in a semiprimitive setting including year-round motorized and nonmotorized recreation.
- 2B** MANAGEMENT AREA 2B - Provides opportunity for outdoor recreation in a wooded natural and rural setting including developed recreation facilities and year-round motorized and nonmotorized recreation.
- 3A** MANAGEMENT AREA 3A - Provides opportunity for nonmotorized recreation in a nowilderness semiprimitive setting.
- 4B** MANAGEMENT AREA 4B - Provides wildlife habitat needs and permits dispersed nonmotorized and motorized recreation.
- 5B** MANAGEMENT AREA 5B - Emphasizes the management of big game winter and summer range.
- 6A** MANAGEMENT AREA 6A - Emphasizes forage production for permitted livestock through extensive grazing practices on forested areas which are capable and suitable for range management.
- 6B** MANAGEMENT AREA 6B - Emphasizes forage production for permitted livestock through intensive grazing practices on forested areas capable and suitable for range management.
- 7A** MANAGEMENT AREA 7A - Emphasizes productive tree stand management on lands available, capable and suitable for production of a variety of commercial and noncommercial wood products.
- 8A** MANAGEMENT AREA 8A - Provides for a primitive recreation opportunity as free as possible from the influence of human activity within Congressionally designated and proposed wildernesses.

- 8B** MANAGEMENT AREA 8B - Provides for a primitive recreation opportunity in areas of low use and essentially unmodified natural environment within Congressionally designated and proposed wildernesses.

- 8C** MANAGEMENT AREA 8C - Provides for a semiprimitive recreation opportunity in areas of moderate to low use within Congressionally designated and proposed wildernesses.

- 8D** MANAGEMENT AREA 8D - Provides for the management of heavily used transitional areas near major trailheads and developments within Congressionally designated and proposed wildernesses.

- 9A** MANAGEMENT AREA 9A - Riparian area management. Resource use will be managed to protect and maintain the riparian area. Vegetation treatment will enhance plant and animal diversity. Primitive, semiprimitive, nonmotorized, semiprimitive motorized, roaded natural and rural recreation opportunities can be provided.
Only those 9A management areas which are practical to portray on this map are shown. The Forest Plan map shows riparian areas in greater detail.
- 9B** MANAGEMENT AREA 9B - Emphasizes the production of available water through vegetative manipulation and/or structural and nonstructural improvements.
- 9D** MANAGEMENT AREA 9D - Emphasizes the protection and rehabilitation of watersheds to protect and/or improve water quality and soil stability.
- 10A** MANAGEMENT AREA 10A - Provides for the management of existing or potential research natural areas.
- 10B** MANAGEMENT AREA 10B - Provides for the management of existing experimental forests.

The management requirements for individual management areas are described in Chapter III of the Forest Plan.



- S** Special areas designated for particular purposes, managed according to terms of the respective designation documents and the Forest-wide direction:
 - SA Air Force Academy Withdrawal
 - SE Manitou Experimental Forest
 - SL Spanish Peaks National Natural Landmark
 - SN Hurricane Canyon and Saddle Mountain Research Natural Areas
 - SR Scenic River Corridor (Eligible for Suitability Study)
 - SS Windy Ridge Bristlecone Pine Scenic Area
 - ST Continental Divide National Scenic Trail Corridor
 - Lands where conditions which would result in recommended denial of lease application are preponderant.
 - Lands where conditions which would result in recommended leasing with no surface occupancy are preponderant.
 - No mineral leases will be issued in these areas until Congress acts on the suitability or unsuitability for wilderness.
- Conditions which would result in recommended leasing with surface occupancy, with appropriate stipulations to protect surface resources, are preponderant on all other nowilderness lands covered by this Plan. As of January 1, 1984 there is no mineral leasing within designated wilderness.
