## Accomplishments Provided with Recreation Fees:

### Developed Recreation and Partnerships

- Funded an agreement with the Bureau of Land Management (BLM) to support a joint BLM-FS recreation crew who completed operation and maintenance tasks.
- Cleaned and maintained vault toilets and fire rings, removed graffiti, and picked up litter at sites across the forest.
- Provided recreation and forest information to visitors; promptly updated and posted information at campground and trailhead kiosks.
- Tested drinking water at campgrounds and recreation rentals.
- Partnered with a BLM recreation crew, and Back Country Horsemen of Oregon to repair a trailhead fence, and install a gate and new sign board.



## Special Feature

Overnight rental of repurposed fire lookouts remains one of the most sought-after recreation opportunities by national forest visitors. The most popular on the Malheur is Fall Mountain Lookout. This easily accessed lookout provides outstanding views of John Day valley and the surrounding Blue and Strawberry mountains. Rental fees are used to keep the lookout cleaned and maintained. Plan your visit between mid-August and mid-September and enjoy huckleberry picking as well as wildlife viewing and star gazing.
