## EMERGENCY ORDER for SPECIAL CLOSURE Seward and Glacier Ranger Districts

Pursuant to Title 36 Code of Federal Regulations 261.50 (a) and (b), the following restrictions are in effect on the Seward and Glacier Ranger Districts of the Chugach National Forest. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations, and become effective when signed and will remain in effect until rescinded.

Prohibited Acts:

36 CFR 261.53 - Special Closures  
36 CFR 261.53(f) – Property

Due to inadequate snow conditions and to prevent resource damage, operating or possessing a snowmobile on the Glacier and Seward Districts except for the Snug Harbor Road access to Lost Lake Trail and Turnagain Pass area as shown in the attachment is prohibited.

Exceptions:

Pursuant to Title 36 CFR 261.50 (e) the following are exempt from this order:

1. Any person with a permit authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

This order is effective until rescinded.



Snow Machine Use**


Turnagain Arm

All National Forest System lands within the boundaries of the Municipality of Anchorage and Kenai Borough, EXCEPT for Turnagain Pass west of the Seward Highway, north of the Turnagain Pass parking lot, and Seattle Creek watershed, and EXCEPT for the area accessible from Snug Harbor Road, south of Kenai Lake, west of the Seward Highway and Primrose Campground, and north of Resurrection River. Areas that remain Open to Winter Motorized Use lie within T9N.R1E, T9N.R2E, T8N.R1E, T8N.R2E, T3N.R1W, T3N.R2W, T3N.R3W, T2N.R1W, T2N.R2W, T1N.R1W, T1N.R2W, Seward Meridian.
