EMERGENCY ORDER for FIRE

KENAI PENINSULA
Glacier & Seward Districts

Pursuant to Title 36 Code of Federal Regulations 261.50 (a) and (b), the following restrictions are in effect on all lands administered by the Chugach National Forest on the Seward and Glacier Ranger Districts. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations, and become effective when signed and will remain in effect until rescinded.

Prohibited Acts:

36 CFR 261.52 – Fire

A. For the purpose of this order, building, maintaining, attending or using a fire, or campfire is prohibited, including charcoal or other types of fuel, except for fires fueled by pressurized gas (eg. Coleman Stove).

See attachment A for closure area [Title 36 CFR 261.52 (a)].

B. Smoking, except within an enclosed vehicle or building, a developed campground, or any other recreation site, or while stopped in an area at least three feet in diameter, which is barren or cleared of all flammable material.

Exceptions:

Pursuant to Title 36 CFR 261.50 (e) the following are exempt from this order:

1. Any person with a permit authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.
3. Any Federal, State, or local law enforcement officer in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.


