Pursuant to Title 36 Code of Federal Regulations 261.50(a)
THE FOLLOWING ACTS ARE PROHIBITED IN THE PACK CREEK COOPERATIVE MANAGEMENT AREA
 as described in this order
 within the Tongass National Forest
 Chatham Area, Admiralty Island National Monument
UNTIL FURTHER NOTICE

1. All Year:

a. Public use on National Forest lands at Pack Creek covered by the improvements of Stan Price is prohibited (residences, wood sheds, out buildings, miscellaneous buildings and the north garden). (36 CFR 261.57(a))

b. Camping is prohibited. (36 CFR 261.58(e))

2. **Between May 1 and September 30:** Possessing or storing any food or food refuse within the area is prohibited, unless placing in the designated food cache. (36 CFR 261.58(cc)).

3. **Between June 1 and September 10:** Public use from 9 p.m. to 9 a.m. is prohibited. Public use from 9 a.m. to 9 p.m. is allowed only on the Pack Creek trail and observatory and from the trailhead north past the boat outhaul to the viewing spit. During this use a permit must be in possession. (36 CFR 261.57(a)).

Pursuant to Title 36 CFR 261.50 (e), the following persons are exempt from this order: Any Federal, State, or local officer or member of an organized rescue or firefighting force in the performance of official duty.

The area affected by this order includes all National Forest System lands within the Pack Creek Cooperative Management Area which includes all areas above mean high tide line in the west 1/2 of Sections 5 and 8 and Sections 6 and 7, T46S, R69E, CRM as shown on USGS quad Sitka D-1.

Violations of the above prohibitions are punishable by a FINE of not more than \$5000.00 or IMPRISONMENT of not more than 6 months or BOTH.



POSTING INSTRUCTIONS (per 36 CFR 261.51)

1. A signed copy of this order shall be available at the public reception area of: a) the Forest Supervisor's Office, and b) the Admiralty Island National Monument Office, and c) the Juneau Ranger District Office and shall be readily visible to the public.
2. A brief press release shall be prepared and published in the JUNEAU EMPIRE Informing residents of the new prohibitions.
3. A copy of the signed order and any applicable mapping shall be posted in the area the prohibition pertains to, readily visible to the public.
4. Copies of this order are to be sent to Alaska State Troopers. (to be done by Area Special Agent)
