

These campgrounds and developed sites are managed by Recreation Resource Management of America (RRM) under a special use permit with the Forest Service.

+ Visitors who are registered in RRM operated campground will not need to pay in Day Use Areas, but must display their hang tag. Hang tag provided.

2nd vehicles being used as a camp unit will be charged full camping rate.

Non-campground guests may dump their trash at a RRM campsite dumpster for a fee of \$5.00 per bag.

Golden Age, Golden Access and Interagency Senior & Access Pass 50% discounts apply to campsite fee only.

All camp sites have a limit of 2 vehicles or 8 persons.
You may picnic in campgrounds (10 am to 2 pm) \$2 per hour (2 hour minimum)
Hours of use will be paid for in advance.

Welcome to our National Forest Campgrounds

As a visitor to the National Forest, the following reminders protect the natural environment and ensure your health and safety.

1. You must pay a fee to use certain campgrounds or day use areas. These sites are clearly signed or posted as requiring a fee.
2. Throw all garbage and litter in containers provided for this purpose or take it with you.
3. Obey road and trail restrictions on ATV or motorcycle use.
4. Build fires only in fire rings or grates provided. You are responsible for keeping fires under control. Be sure your fire is completely out before leaving the campground. Firewood size must fit inside fire ring.
5. Do not carve, chop, cut or damage any living trees.
6. Please keep noise to a reasonable level. Be courteous to your fellow visitor.
7. Pets must always be on a leash.
8. Horses are not allowed in campgrounds.
9. Use of fireworks is prohibited in the National Forests.
10. Firing a gun is not allowed within 150 yards of the campground, across a road or lake, or in any circumstance where a person may be injured or property damaged.
