**SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FORESTS
HEBER-KAMAS RANGER DISTRICT**

TEMPORARY ROAD CLOSURE

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following acts are prohibited** on the National Forest System road as described in this Order, all within the Heber-Kamas Ranger District, Uinta-Wasatch-Cache National Forests. This Order is in effect until further notice

1. **Being on the road** as described below and shown on the attached map with any type of motorized vehicle. [36 CFR 261.54(a)]
2. **Being on the road** as described below and shown on the attached map with any type of motorized vehicle. [36 CFR 261.54(a)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

Forest Service Road #70901 will be closed from the junction with Forest Road #70026 to where the road ends located in Township 1 South, Range 11 West, Section 5; Township 1 South, Range 11 West, Section 8 all within the Uintah Based Meridian and as shown on the attached map. Forest Service Road #270026 will be closed from the junction with Forest Service Road #70901 to where the road ends located in Township 1 South, Range 11 West, Section 5; Township 1 North, Range 11 West, Section 33 all within the Uintah Based Meridian and as shown on the attached map.


PURPOSE:

Purpose of the Order is to provide for public health and safety during the 2014 Annual Rainbow Family Gathering.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].
