FOREST ROAD 5506 CLOSURE

ORDER NO. T2014-0614-NF-01

Pursuant to 36 CFR, Sec. 261.50 (a) and (b), the following acts are prohibited on the area described in this order within the Umatilla National Forest, until further notice.

- 1) When provided by an order, the following are prohibited: It is prohibited for any person to operate street legal full size vehicles or a Class II OHV on the section for Forest Service Road 5506 as shown on the attached map (Exhibit A). Open to all other traffic.
36CFR 261.54 (a)

Pursuant to 36 CFR, Sec. 261.50 (e), the following persons are exempt from this order:

- 1) Persons with a permit specifically authorizing the otherwise prohibited act or omission.
- 2) Any Federal, State or local law enforcement officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- 3) An employee of the Forest Service when performing their official duties.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.



Closure area description:

The closure area on Forest Service Road (FSR) 5506 from its junction with FSR 5506-130 to end of road at North Fork John Day Wilderness in T. 7S R33E Sec 13.



Enforcement Plan

Statement of Need:

Due to wash out portions of Forest Service Road (FSR) 5506 from its junction with FSR 5506-130 to end of road at North Fork John Day Wilderness in T. 7S R33E Sec 13 described in Exhibit A - all street legal full size vehicles and Class II OHV traffic will be prohibited to ensure the public's safety. Open to all other traffic.

Enforcement Procedures:

Enforcement of this order will be performed by LEOs, FPOs and Special Agents. It will be at their discretion at the level of enforcement taken when enforcing this order.
