




Hulk Sale Area and Slash Disposal Map Lookout Mountain Ranger District, Ochoco National Forest

Protect all National Forest Property Boundary markers, stakes, and signs along private land, BT6.23.

Boundary tags posted on the ground are marked as 'Hulk' Timber Sale, BT1.1

Cutting Units 41, 42, 49, 50, 51, 52, 53, 55, 56 where the boundary is not posted and painted along the 33 road, the road is the boundary, BT1.1.

Cutting Units 44, 45, 48, 49, 64, where the boundary is not posted and painted along the 27 road, the road is the boundary, BT1.1.

Landlines shown on Sale Area Map are approximate.

All sale roads are restricted, CT5.12#.

Roads to be kept open, applies to all roads listed in CT5.31#.

Purchaser and Forest Service will agree on procedures for Purchaser use of roads behind gates, BT5.12 & CT6.315#.

Scarification and seeding of landings and temporary roads, and 300' of the skid trail from the landing required, CT6.6#.

All construction and landing slash shall be piled, CT6.74#.

Leave trees are marked on the side of the tree facing away from road within 75' of roads 27 and 33. This applies to cutting units 41, 42, 44, 45, 48, 49, 50, 51, 52, 53, 55, 56, and 64, AT6 & CT6.41#.

Stump Heights: 8 inch or less stump height required within 75 feet from the edge of 27 and 33 roads in cutting units 41, 42, 44, 45, 48, 49, 50, 51, 52, 53, 55, 56, and 64, AT6 & CT6.41#.

Slash Treatment Requirements: Slash Plans and Specifications for Yarding, and/or Decking Slash on Landings and Temporary Roads applies to all cutting units.
