On 08/26/2014, at 09:00 AM, sealed bids will be opened in the TELL CITY RANGER DISTRICT 248 15TH STREET TELL CITY IN 47586 for the Saddle sale. This sale is located in Perry County, Indian Celina recreation area west of State Route 37 in T4SR2W Sec 3 and 4 & south of State Route 62 in T3SR2W Sec 28, 29, and 33.. Timber sale Contract 2400-6T will be used. The termination date for this sale is 12/31/2017.

There are 0.05 miles (0.08 kilometers) of specified road reconstruction, and 0.42 miles (0.68 kilometers) of specified road construction. A specified road construction cost of \$49,988.52 has been allowed in the appraisal for this work.

The estimated quantities in this contract have been determined prior to felling. The total estimated quantity on this sale is 1,663 CCF.
