South Fork Complex Fire Closure

ORDER NO. T-2014-0604-MAL-02


Pursuant to 36 CFR, Sec. 261.50(a) and (b), the following acts are prohibited on the areas and National Forest System roads described in this order within the Malheur National Forest until further notice.

1. Going into or being upon an area. For the purpose of this order, this prohibition applies to persons going into or being upon the areas described in Appendix A of this order (36 CFR 261.52(e)).
2. Being on the road. For the purpose of this order, this prohibition applies to persons being on a National Forest System road within and on the perimeter of the area listed in Appendix A of this order (36 CFR 261.54(e)).

Pursuant to 36 CFR, Sec. 261.50 (e), the following persons are exempt from this order:

- (1) Persons with a permit specifically authorizing the prohibited act or omission.
- (2) Any Federal, State or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
- (3) Owners or lessees of land within the area.

Violation of these prohibitions is punishable by a fine of not more than \$5000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. (16 U.S.C. 551 and 18 U.S.C. 3559 and 3571)

APPENDIX A

Area Descriptions: South

Fork Complex Fire

That area lying within the following perimeter:

The Malheur National Forest (MNF) boundary from the point of intersection with Forest Road(FR) 21 in sec. 1 Township13s, Range28e west to the northwest corner of sec. 33, T13s, R27e.


South along the MNF boundary to the intersection with FR 6370 in sec 25, T16s, R27e.

East along FR 6370 to the MNF boundary in sec 1, T17s, R28e.

North and east on the MNF boundary to the intersection of Grant County (GC) 63.

East along GC 63 to FR 2195.

Northeasterly along FR 2195 to FR 21 and north to the point of origin at the MNF boundary.

Assessment of Need and Enforcement Plan

1. Background:

These restrictions have been deemed necessary because of the hazards associated with the South Fork Complex Fire. This order reduces the affected area to those that are still at risk from active fire.
