

ORDER NO. 14-05-752
KLAMATH NATIONAL FOREST
ORDER NO. RSF-233
ROGUE RIVER- SISKIYOU NATIONAL FOREST
EMERGENCY CLOSURE

Pursuant to 16 USC 551 and 36 CFR 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Klamath National Forest and Rogue River - Siskiyou National Forest. This Order is effective from August 15, 2014, until the Beaver Fire is fully suppressed.

1. Going into or being upon National Forest System lands within the Beaver Fire Closure Area. The boundary of the Beaver Fire Closure Area begins at the intersection of Highway 96 and Seiad Creek Road (County Road 8D002); then continues northerly along the eastern edge of Seiad Creek Road (County Road 8D002) to its intersection with Horse Creek Road (Forest Road No. 46N50); then continues northeasterly along the eastern edge of Horse Creek Road (Forest Road No. 46N50) to its intersection with Salt Gulch; then continues northerly along Salt Gulch until its terminus; then continues directly north to the Pacific Crest Trail (Forest Trail No. 2000); then continues northeasterly along the Pacific Crest Trail (Forest Trail No. 2000) to its intersection with Siskiyou Summit Road (Forest Road No. 40S01); then continues northeasterly along the eastern edge of Siskiyou Summit Road (Forest Road No. 40S01) to its intersection with Deer Creek Ridge Road (Forest Road No. 41S15); then continues easterly along the southern edge of Deer Creek Ridge Road (Forest Road No. 41S15) to its intersection with Long John Road (Forest Road No. 41S16); then continues southerly along the western edge of Long John Road (Forest Road No. 41S16) to its intersection with Beaver Creek Road (Forest Road No. 11); then continues easterly along the southern edge of Beaver Creek Road (Forest Road No. 11) to its intersection with the National Forest boundary; then continues southerly along the National Forest boundary to its intersection with Highway 96; then continues westerly along the northern edge of Highway 96 back to the starting point, as shown on the attached map. 36 CFR 261.53(e).
2. Being upon any National Forest System road in the Beaver Fire Closure Area, as shown on the attached map. 36 CFR 261.54(e).
3. Being upon any National Forest System trail in the Beaver Fire Closure Area, as shown on the attached map. 36 CFR 261.55(a).

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

1. Persons with a permit from the Forest Service specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

3. Owners or lessees of private land in the Beaver Fire Area to the extent necessary to gain access to their land.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both.
16 USC 551 and 18 USC 3559, 3571, and 3581.


