South Fork Complex Fire Closure

ORDER NO. T-2014-0604-MAL-11

Pursuant to 36 CFR, Sec. 261.50(a) and (b), the following acts are prohibited on the areas and National Forest System roads described in this order within the Malheur National Forest until further notice.

1. Going into or being upon an area. For the purpose of this order, this prohibition applies to persons going into or being upon the areas described in Appendix A of this order (36 CFR 261.52(e)).
2. Being on the road. For the purpose of this order, this prohibition applies to persons being on a National Forest System road within and/or listed in Appendix B of this order (36 CFR 261.54(e)).

Pursuant to 36 CFR, Sec. 261.50 (e), the following persons are exempt from this order:

- (1) Persons with a permit specifically authorizing the prohibited act or omission.
- (2) Any Federal, State or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
- (3) Owners or lessees of land within the area.

Violation of these prohibitions is punishable by a fine of not more than \$5000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. (16 U.S.C. 551 and 18 U.S.C. 3559 and 3571)

APPENDIX A

Area Descriptions:

South Fork Complex Fire

That area lying within the following perimeter:

The Malheur National Forest (MNF) boundary north of Cabbage Patch Spring at the NW corner of sec. 1 Township 14S, Range 27E, west to the northwest corner of sec. 33, T13S, R27E.

South along the MNF boundary to the intersection with FR 24 in sec 10, T16S, R27E.

East along FR 24 to FR 2180 in sec. 10, T16S, R28E.

North and east on FR 2180 to FR 21.

North on FR 21 to FR 2150.

North and west FR 2150 to intersection with west side of sec. 12, T14S, R27E near Cabbage Patch Spring.

North on west side section line of sec. 12 and sec. 1, T14S, R27E to MNF boundary.

Appendix B
Road Closures:

FR 2150, from FR 21 west to end of road at Aldrich Lookout.

FR 24, from west MNF boundary to FR 2400-270 in sec. 10, T16S, R27E (Dewey Creek)

All FS roads within area closure and specifically "Green Dot" roads within area closure to include FR 2150, FR 2150-039, FR 2150-070, FR 2170, FR 2490, FR 2480, FR 2490, FR 2490-269, FR 2400-389, FR 2490-228, FR 2490-213.
