Please utilize these instructions as direction for management on your grazing allotment during the 2014 Grazing Season. We appreciate your cooperation in the management of your livestock throughout the 2014 grazing year.

Kline Permit

Non-Use

As per FSM 2231.61 (Gila Supp #23), I am informing you that this is your second year of partial Personal Convenience Non-Use. In order to maintain full permitted numbers you are required to stock up to 90% of the permitted numbers by the 4th year (2016). If you foresee that, fully stocking by 2016 will not be possible due to resource concerns, please contact Monte on alternatives such as a Memorandum of Understanding allowing for Resource Protection Non-Use.

Grazing Restriction:

The Tularosa Gauging station is excluded from livestock use yearlong. The purpose of this restriction is to provide measures to mitigate impacts on wildlife.

Allowable Use:

The Environmental Assessment and Decision Notice dated September 1, 1995 set guidelines for utilization of key forage species at 35% allowable use.

Utilization Monitoring:

Utilization monitoring will be conducted on or near key areas of your allotment. District personnel will monitor pasture use and determine utilization percentage at that time.

Monitoring dates will be set according to the previous years monitoring results. If pastures were approaching allowable use during the 2013 grazing season they will be monitored at the mid-point of the pasture use period to determine if it is necessary for livestock to be moved to the next pasture in the rotation. Please note the following approximate dates that are scheduled for monitoring on the West Sand Flat Allotment. You are encouraged to participate in monitoring utilization levels.

2014 Monitoring Dates:

Pasture	Monitoring Dates
Sand Flat North	04/15/14, 5/15/14
Sand Flat South	10/02/14
Apache Mountain	11/17/14

If utilization levels are approaching allowable use levels, livestock will be required to be moved to areas within the pasture that are not approaching allowable use levels. If areas well under utilization levels are unavailable within the pasture, livestock will be moved to next scheduled pasture. If there are no pastures that remain under utilization, livestock will be required to move to private lands.

2013 monitoring results show 0 accounts of over utilization; I appreciate your efforts in management of livestock to comply with utilization standards.

Forage Growth and Water Availability:

If forage growth and/or water availability are not adequate during all or portions of the 2014 grazing season, total or partial livestock removal will be necessary. Part 2, clause 8(c) of the grazing permit provides this option.

Range Improvements:

All assigned range developments identified in the Term Grazing Permit will be maintained to a functional status.

Actual Use:

Actual use data provided to the District was calculated at 134 AM's for the Lumpkin permit and 579 AM's for the Kline permit for a total of 714 AM's for the 2013 grazing season.
