On 10/21/2014, at 10:00 AM, sealed bids will be opened in the Plumas National Forest, Supervisor's Office, 159 Lawrence St. Quincy, CA 95971 for the Gallagher MP Thin sale. This sale is located in All or portions of T22N., R10E; secs. 4,5,30,31,32; T23N., R11E, secs. 4,9,10,11. Timber sale Contract 2400-6T will be used. The termination date for this sale is 03/31/2018.

There are 0.07 miles (0.11 kilometers) of specified road reconstruction. A specified road construction cost of \$12,484.38 has been allowed in the appraisal for this work.

The estimated quantities in this contract have been determined prior to felling. The total estimated quantity on this sale is 20,090 CCF.
