FOREST DEVELOPMENT ROAD SPECIAL ORDER

**PROHIBITIONS:**

Pursuant to 36 CFR 261.50 (a) and (b), the following acts are prohibited on the area, roads, and trails as described in this order, all within the Ogden Ranger District, Wasatch-Cache National Forest until further notice:

Subpart B--Prohibitions in Areas Designated by Order

Sec. 261.50 Orders.

(a) The Chief, each Regional Forester, each Experiment Station Director, the Administrator of the Lake Tahoe Basin Management Unit and each Forest Supervisor may issue orders which close or restrict the use of described areas within the area over which he has jurisdiction. An order may close an area to entry or may restrict the use of an area by applying any or all of the prohibitions authorized in this subpart or any portion thereof.

(b) The Chief, each Regional Forester, each Experiment Station Director, the Administrator of the Lake Tahoe Basin Management Unit and each Forest Supervisor may issue orders which close or restrict the use of any National Forest System road or trail within the area over which he has jurisdiction.

For the purposes of this order, the use of wheeled motorized vehicles is prohibited. (Title 36 CFR 261.54 (a))

1. Using wheeled motorized vehicles on the portion of Forest Development Road #20092 described below in **AREA DESCRIBED**.
2. Using wheeled motorized vehicles on Road #20220 and Road #20092 (that portion of the road not included in 1. above, and as described below in Section C 2.) during seasonal closure. **Seasonal closure shall be defined as November 1 thru May 15, or at any time when the gate at the intersection of Road #20092 and the Avon-Liberty Road (SR162) is locked.**

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e), the following are exempt from this order:

1. Persons with a special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, local officer, or member of an organized rescue, or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in the performance of an official duty.

### **AREA DESCRIBED:**

All National Forest System Lands Described below:

1. The area is located in Cache County approximately 25 miles northeast of Ogden, UT. Road #20092 starts at the intersection of the Avon-Liberty County road (SR 162) in the NW1/4 of the SE1/4 of Section 29, T.8N., R.1E., SLM and proceeds 1.0 mile NE to the intersection with Road #20220, SW1/4 of the SE1/4 of Section 20, T.8N., R.1E., SLM.
2. Road #20220 (starts at the intersection with Road #20092 in the SW1/4 of the SE1/4 of Section 20, T.8N., R.1E., and proceeds 1.5 miles NW to the Honey Bee Mine area in the SW1/4 of the NW1/4 of Section 17, T.8N., R.1E., Salt Lake Meridian; and the remaining portion of Road #20092 (starting at the intersection of the Avon-Liberty County road (SR 162) in the SW1/4 of the SW1/4 of Section 21, T.8N., R.1E., Salt Lake Meridian and proceeds .8 miles westerly to the intersection with Road #20220, SW1/4 of the SE1/4 of Section 20, Salt Lake Meridian .


### **PURPOSE:**

This order is for public safety, protection of area vegetation, road surfaces, protection of springs, ponds, and water courses, and to restore damaged resources and road damage.

### **IMPLEMENTATION:**

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. A map identifying the closure area is attached and made part of this Order.
3. Violation of this prohibition is punishable by a fine of not more than \$5,000.00 and/or imprisonment of not more than (6) months. [Title 16 USC 551, Title 18 USC 3571(b)(6). Title 18 USC 3581 (b)(7)]

5. This order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the areas (and/or roads, trails covered by this Order.
