UPPER ROGUE COOPERATIVE TRAVEL MANAGEMENT AREA  
HIGH CASCADES RANGER DISTRICT

Pursuant to Title 36 CFR Part 261.50(a) and (b), the following acts are prohibited within the boundaries of the High Cascades Ranger District, Rogue River-Siskiyou National Forest, as described in this order, and attached Exhibits A, **from 0001 hours October 15, 2014 until 2400 hours October 24, 2014.**

**FOREST DEVELOPMENT ROADS**

1. Being on a closed road with any motor vehicle within the Upper Rogue Cooperative Travel Management Area. **36 CFR 261.54(e)**

**USE OF VEHICLES OFF FOREST DEVELOPMENT ROADS**

1. Possessing or using any motor vehicle off road within the Upper Rogue Cooperative Travel Management Area. **36 CFR 261.56**

**FOREST DEVELOPMENT TRAILS**

1. Being on a trail with any motor vehicle off road within the Upper Rogue Cooperative Travel Management Area. **36 CFR 261.55(b)**

**PARKING**

1. Parking or leaving a vehicle in violation of posted instructions. **36 CFR 261.58(g)**

Pursuant to Title 36 CFR Part 261.50(e), the following persons are exempt from this order:

1. Persons with a permit authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in Title 36 CFR 261, Subpart A.

Violations of these prohibitions are punishable by a fine of not more than \$5,000.00 for an individual or \$10,000 for an organization or imprisonment for not more than six (6) months, or both, for each offense. 16 USC 551 and 18 USC 3559 and 3571.

### **EXHIBIT A**

UNDER THE AUTHORITY OF 36 CFR 212.7(20) (II) (II) and OAR 21-180 AND OR 496-992 PERTAINING TO THE MEMORANDUM OF UNDERSTANDING AGREEMENT BETWEEN THE ROGUE RIVER-SISKIYOU NATIONAL FOREST AND THE OREGON DEPARTMENT OF FISH AND WILDLIFE, THE OPERATION OF MOTOR-PROPELLED VEHICLES IS RESTRICTED AS DESCRIBED IN SECTION 1 AND SECTION 2 BELOW.

VIOLATION OF THE RESTRICTION DESCRIBED IN SECTION 1 AND SECTION 2 BELOW ARE VIOLATIONS OF FEDERAL REGULATIONS AND OREGON STATE LAW AND ARE CRIMINAL MISDEMEANORS.


#### **SECTION 1 – AREA OF RESTRICTIONS**

The vehicle restrictions outlined in Section 2 below shall apply to those portions of the Rogue River-Siskiyou National Forest contained within the Rogue and Dixon Game Management Units, as described in the “Western Oregon Wildlife Management Unit Maps and Boundary Descriptions” and including parts of T.28S., R.03E., R.04E., R.05E.; T.29S., R.03E., R.04E., R.05E.; T.30S., R.02E., R.03E., R.04E., R.05E.; T.31S., R.01E., R.02E., R.03E., R.04E., R.05E.; T.32S., R.02E., R.03E., R.04E.; T.33S., R.03E., R.04E., R.05E.; T.34S., R.04E., R.05E.; T.35S., R.02E., R.03E., R.04E.; T.36S., R.03E., R.04E.; T.37S., R.03E., R.04E., R.05E.

#### **SECTION 2 – RESTRICTIONS**

(a) The use of motor-propelled vehicles shall be restricted to only those roads indicated and identified on the map attached as Exhibit B, which displays the restricted area boundary and roads open to travel (exceptions under b). For the purpose of these restrictions, roads open to travel are defined to include the area within 300 feet either side of center. Motor-propelled vehicle use within 300 feet of the centerline of roads open to travel is permitted for the purpose of moving to and from campsites and woodcutting only. No other purpose is authorized. (See part B below).

(b) Motor-propelled vehicle entry may be permitted in restricted areas for fire and law enforcement or by special permit. Special permits may be issued by the High Cascades District Ranger, Rogue River-Siskiyou National Forest, or his/her authorized representative, for motor-propelled vehicle entry on restricted areas of the Ranger District during the closure period for good cause, as determined by the District Ranger.






