



**ORDER OF THE FOREST SUPERVISOR  
RESTRICTING THE OCCUPANCY AND USE  
ON THE HURON-MANISTEE NATIONAL FORESTS**

**KIRTLAND'S WARBLER**

Under the authority of the Act of Congress of June 4, 1987, as amended (16 USC 551), and the Secretary of Agriculture's Regulations 36 CFR 261.50(a) and or (b), the following acts and omissions are prohibited in Kirtland's warbler (*Setophaga kirtlandii*) area closures on the Huron-Manistee National Forests.

- A. Go into or be upon any area closed for the protection of Kirtland's warblers, as shown on the attached Map Exhibits and as described in the Area Description, during the period of May 1 through August 15. 36 CFR 261.53(a)**

**Pursuant to 36 CFR 261.50 (e) the following persons will be exempt from the order:**

1. Any Federal, State, or Local officers, or members of an organized rescue or firefighting force engaged in the performance of an official duty.
2. Persons with a valid permit in their possession signed by the Forest or District Biologist specifically authorizing the otherwise prohibited act or omission.

**Violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual, \$10,000 for an organization, or imprisonment for not more than six (6) months or both under the authority of Title 16 USC 551, Title 18 USC 3559 and 3571.**
