

FOREST ORDER

WILDFIRE CLOSURE

**MT. HOOD NATIONAL FOREST
Clackamas River Ranger District**

Pursuant to Title 36 CFR 261.50(a) and 36 CFR 261.50(b), and effective immediately the following act is prohibited until further notice, on the area depicted in Attachment A of this order within the Mt. Hood National Forest located in Clackamas County, Oregon. This Forest Order is in effect until rescinded.

The fire closure includes the following Forest Trails:

- (1) Ladee Flats OHV Trails #800, #801, #802, #803, #804, #805, #806 (non-motorized use along the Ladee Flats OHV Trails is allowed outside of fire-burned areas)

The fire closure includes the following Forest Roads:

- (1) Forest Road 4611 from its junction with Forest Road 4610
- (2) Forest Road 45 from its junction with Highway 224 to its junction with the Helion Quarry

The fire closure includes the following area, excluding Highway 224, as depicted on Attachment A:

- (1) Fire-burned areas on National Forest System lands both north and south of Highway 224.

Pursuant to 36 CFR, Section 261.50(e), the following persons are exempt from this order:

- (1) Persons with a permit specifically authorizing the prohibited act or omission.
- (2) Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.

Violations of these prohibitions are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. (16 U.S.C. 551, and 18 U.S.C. 3559 and 3571)
