The Arapaho and Roosevelt National Forests and Pawnee National Grassland (ARP) will soon be advertising temporary positions in both fire and fuels management across the ARP.

Fire and Aviation Management on the ARP:

The Arapaho Roosevelt National Forest and Pawnee National Grassland (ARP) is responsible for wildfire management on 2 million acres of public land in northern Colorado, spread across 7 Counties. ARF Fire resources assist other Federal, State and County Agencies and Fire Protection Districts throughout Colorado, and across the United States when necessary.

The historical wildfire season in northern Colorado peaks from May to October, but can extend from March through November. There are an average of 110 wildfires in the area which encompasses the ARP and surrounding private, State, County and National Park lands. The terrain varies from mountains to the plains and includes timber, brush and grass fuel types. Many wildfires are complicated by proximity to significant wildland urban interface.

ARP firefighting resources consist of: 5 Engines, 1 Interagency Hotshot Crew, 2 Initial Attack Squads, a Helitack Module, 2 Fuels Modules, 2 Fire Prevention units, an Interagency Dispatch Center and a Heavy Air Tanker Base.

The successful applicant should be available for an extended fire season, be prepared for long periods away from home in remote work locations, and be in exceptional physical condition to meet the rigorous demands of wildland firefighting. Work schedules and hours vary widely.

CONDITIONS OF EMPLOYMENT

Successfully complete the WORK CAPACITY TEST (WCT) for Wildland Firefighters. These positions participate in wildland firefighting activities.

- **Forestry Technician and Forestry Aid:** PASSING the WCT at the ARDUOUS level is a "condition of employment." The Arduous fitness (Pack) Test consists of a three (3) mile hike, within forty-five (45) minutes, while carrying a forty-five (45) pound pack.
- **Forestry Technician (Fire Dispatcher):** Does Not need to pass the WCT for employment.

These positions have been identified under the Forest Service Fire Program Management (FS-FPM) and are subject to selective placement factor requirements contained in the FS-FPM Standard and Guide. The applicant will be required to possess these qualifications by the date identified for each position.
