The Prairie City, Blue Mtn. and Emigrant Creek Ranger Districts will be seeking temporary seasonal firefighting employees for the upcoming 2015 wildfire season. These positions will begin on June 14, 2015 with duration of up to four months depending on fire season severity and funding. Positions may be filled on engines and handcrews. Employees could be stationed in **Prairie City, OR, John Day, OR, or Hines, OR, Crane Prairie Guard Station, Blue Mtn. Work Center, Allison Guard Station and Crow Flat Guard Station.** All positions (excluding dispatch and lookouts), require the arduous level physical fitness pack test.
