STATEMENT OF WORK

C.1 SCOPE OF WORK

This statement of work consists of contractor, after 72 hour notice, providing a Type I Dozer (200 Horsepower), or Road Grader (Blade, Ripper, 150 Horsepower), as requested by the Burn Boss, for transport to a prescribed fire unit on the Ashland Ranger District, Custer Gallatin National Forest, to be stationed on standby as a contingency resource in case of a need for line treatment, or if the prescribed fire crosses established lines. Prescribed fires will be on lands administered by the Custer Gallatin National Forest on the Ashland Ranger Districts in the following counties: Rosebud and Powder River, near Ashland, Montana. Work to be performed by the contractor includes: a) transporting the dozer/grader to a designated site near the burn operation b) being immediately ready and available to support the burn effort when called upon by the Burn Boss during that burn period treatment.

The contractor will furnish the equipment, labor, licensing, supervision, workman's compensation, unemployment insurance, transportation, operating supplies and incidentals necessary to safely use the equipment for the project. Equipment being used for the requirements under this contract shall be cleaned prior to entering the Forest and cleaning may be required between sites.

C.2 PERIOD OF PERFORMANCE

Services covered under this contract are to be performed during the base year March 1, 2015, (or when awarded) through September 30, 2015 and for two succeeding years. Work shall commence when prescribed fire units are set to be burned when weather conditions make the units ready under prescription. Individual orders will identify specific start work and completion dates.

C.3 LOCATION AND DESCRIPTION OF PRESCRIBED FIRE AREAS

Project Location

Project areas that are included under this contract are all Forest Service administered lands within the Ashland Ranger District, Custer Gallatin National Forest. Prescribed fire treatments will take place in varying locations on the Ashland Ranger District. Burn Units will be identified in task orders. The District is located in southeastern Montana. The office for the Ashland Ranger District is approximately 125 miles southeast of Billings, Montana, and 44 miles west of Broadus, Montana.

Prescribed Fire Treatment

Prescribed fire treatment will occur on open rangelands and in ponderosa pine timber stands. Treatment areas will be identified on maps. Terrain will vary from gentle (0 to 30%) to slopes up to 60%. The contractor may be required to unload a dozer, or road grader, in an effort to improve prescribed fire treatment lines, or to suppress fire that has crossed designated lines. A designated heavy equipment boss, supplied by the Forest Service, would be placed with the dozer and operator, with appropriate communications, to keep safety as a number one priority during the work effort. Most likely the equipment will not be used and will just sit as contingency for fires across designated control lines.

C.3.1 ACCESSIBILITY

A vicinity map identifying the Ashland Ranger District is attached to this contract. Specific site maps identifying units and road access shall accompany all orders. Within these areas the Forest Service shall select a method of equipment use that meets the contract or task order requirements.

C.4 CONTRACTOR REPRESENTATIVE

The contractor shall provide a contract representative for the performance of work. The name of this person and an alternate(s) who can act for the contractor when the contractor is absent shall be designated in writing to the Contracting Officer. The contractor representative or alternate shall have full authority to act for the contractor on all contractual matters relating to daily operation of this contract.

C. 5 CERTIFICATION AND PERSONNEL REQUIREMENTS

The contractor and employees shall be experienced in fire suppression, with appropriate trainings, to help with the prescribed fire treatment. The contractor performing equipment operations under this contract must meet fire standards and appropriate qualifications. Personnel employed by the Contractor must be briefed and trained in application and safety techniques.

The contractor will show adequate proof of bonding and insurance coverage.

C.6 SAFETY REQUIREMENTS AND GENERAL PROVISIONS

- a. Safety and mitigation requirements, such as a CDL to transport equipment is needed.
- b. The COR will determine when other special safety measures may be required.
- c. The Forest Service is not responsible for the safety of the Contractor nor any operators or assistants. The Contractor shall provide and maintain work procedures which will safeguard the public and Government personnel, as well as the Contractor's own personnel. The Contractor shall be expected to use reasonable safety procedures, protective clothing and equipment while operating on National Forest lands.
- d. The contractor will inspect equipment daily for leaks and suspend operations until all leaks are repaired.
- e. All equipment will be in good mechanical condition and will be inspected prior to work.

C.7 CONSTRUCTING FIRELINE IN PROJECT AREA

The contractor is required to cover all of the project area (task order) to support the prescribed fire project if needed. In any given project area the exact location and the exact fireline construction is unknown. The Forest Service will give the contractor an estimated amount of possible line development at the time of the order, but the amount of line needed for a prescribed fire crossing out of the unit will be unknown until that event.

C.8 FIRELINE CONSTRUCTION STANDARDS

- a. The contractor will construct line at the request of the Burn Boss with an estimated constructed width of one blade wide or less, and just under organic soil to mineral soil.

C.9 PAYMENT

All work shall be recorded by the Burn or Heavy Equipment Boss on an Emergency Response Shift Ticket and signed by both parties. Completed shift tickets will be sent to the Contracting Officer to verify invoice pricing.

The contracting officer shall require that any class of service employee which is not listed herein and which is to be employed under the contract (i.e., the work to be performed is not performed by any classification listed in the wage determination), be classified by the contractor so as to provide a reasonable relationship (i.e., appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination. Such conformed classes of employees shall be paid the monetary wages and furnished the fringe benefits as are determined (See 29 CFR 4.6(b)(2)(i)). Such conforming procedure shall be initiated by the contractor prior to the performance of contract work by such unlisted class(es) of employees (See 29 CFR 4.6(b)(2)(ii)). The Wage and Hour Division shall make a final determination of conformed classification, wage rate, and/or fringe benefits which shall be retroactive to the commencement date of the contract (See 29 CFR 4.6(b)(2)(iv)(C)(vi)). When multiple wage determinations are included in a contract, a separate SF-1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

- 1) When preparing the bid, the contractor identifies the need for a conformed occupation(s) and computes a proposed rate(s).
- 2) After contract award, the contractor prepares a written report listing in order the proposed classification title(s), a Federal grade equivalency (FGE) for each proposed classification(s), job description(s), and rationale for proposed wage rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.
- 3) The contracting officer reviews the proposed action and promptly submits a report of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employees, to the Wage and Hour Division, U.S. Department of Labor, for review (See 29 CFR 4.6(b)(2)(ii)).
- 4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or notifies the contracting officer that additional time will be required to process the request.
- 5) The contracting officer transmits the Wage and Hour decision to the contractor.
- 6) The contractor informs the affected employees.

Information required by the Regulations must be submitted on SF-1444 or bond

paper.

When preparing a conformance request, the "Service Contract Act Directory of Occupations" (the Directory) should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split, combine, or subdivide classifications listed in the wage determination.
