If yes, what were they? **Horses were in the wrong pastures prior-to or beyond the on/off dates. Horses were found as late as November 5 in Unit 1 and in Unit 3 until November 20. Unit 1 was to be rested in 2014 and livestock were supposed to be off the entire allotment by October 7.**
7. Were there any unexpected circumstances or events that resulted in impacts beyond those anticipated in the Forest's in the Biological Assessment or the Service's Biological Opinion? If yes, please describe. **Greenline stubble was exceeded on the Blue Fork of Silver Creek in the Prairie Basin Unit (indicator was $\geq 4''$, actual was 3.4").**

Horses were found in the wrong pastures prior-to or beyond the on/off dates. Due to Clay Jones's repeated violations, the C-YF District Ranger made a decision to permanently cancel 25% of his term grazing privilege.
