

**ORDER NO. 15- 09**  
**SEQUOIA NATIONAL FOREST**  
**WESTERN DIVIDE RANGER DISTRICT**  
**National Forest Area, Trail and Road Closures**

Pursuant to 16 USC 551 and 36 CFR 261.50(b), and to protect public safety, the following acts are prohibited within the Western Divide Ranger District of the Sequoia National Forest. This Order is effective from April 22, 2015 until July 1, 2015.

1. Going into or being upon the George Bush Tree Closure Area, which includes the area within 150 feet of Forest Trail No. 32E20.2 (George Bush Trail Loop) and the associated parking lot in Sections 28 and 33, Township 20 South, Range 32 East, Mount Diablo Base and Meridian, and is shown as closed on the attached map.

36 CFR 261.53(e).

2. Being on the National Forest System road listed below and shown as closed on the attached map.

Forest Road No. 20S78 from its intersection with Forest Road No. 22S82 (Lloyd Meadow Road), then west approximately 2 miles to the parking lot, in Section 27, Township 20 South, Range 32 East, Mount Diablo Base and Meridian.

36 CFR 261.54(e).

3. Being on the National Forest System trails listed below and shown as closed on the attached map.

a. Forest Trail No. 32E20 (Freeman Creek Trail) from its intersection with Forest Road No. 22S82 (Lloyd Meadow Road), then west for approximately 2.1 miles to the southern boundary of the George Bush Tree Closure Area, including those portions of the Freeman Creek Trail that fall within the George Bush Tree Closure Area.

b. Forest Trail No. 32E20.2 (George Bush Trail Loop).

36 CFR 261.55(a).

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

Any Federal, State or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 USC 551 and 18 USC 3559, 3571, and 3581.


