

**ORDER 18-2013-04-04****OCCUPANCY AND USE
Developed and Dispersed Recreation Restrictions****WILLAMETTE NATIONAL FOREST
Detroit Ranger District**

Pursuant to 36 CFR 261.50(a), the following acts are prohibited in the areas as described in this order within the Willamette National Forest. This order will become effective upon signature, and will remain in effect until rescinded.

1) Camping. §36CFR 261.58(e)

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

- 1) Persons with a permit specifically authorizing the otherwise prohibited act or omission.
- 2) Any Federal, State or local officer, or member of an organized rescue or fire fighting force while in the performance of an official duty.
- 3) Any persons camping in the affected area within developed fee campgrounds.

DESCRIPTION OF AREA:**Breitenbush Corridor**

- Beginning at the junction of Forest Road 46 (Breitenbush Road) and the Forest Boundary, the affected area is 500 feet from the eastern edge of Forest Road 46 for approximately 1 mile,
- Due north approximately 200 feet from the high water mark of the north side of the Breitenbush River,
- Southwest approximately 200 feet from the high water line of the Breitenbush Arm of Detroit Lake until the intersection of Forest Road 450,
- Due south to the intersection of Highway 22,
- Southeast along Highway 22 until the Forest Boundary,
- East along Forest Boundary to point of origin. **See attached map (Exhibit A)**

French Creek Corridor

- Beginning at the junction of Forest Road 2223 (French Creek Road) and Highway 22, the area 200 feet from the west edge of Forest Road 2223, north for ½ mile,
- East until the intersection of French Creek,
- South along French Creek until the intersection of Highway 22,
- Northwest along Highway 22 to point of origin. **See attached map (Exhibit A)**

Tumble Creek Trail (Detroit Lake) #3380

- The area within a 1/3 mile radius from the parking area at the Tumble Ridge Trailhead (#3380) at Detroit Lake. See attached map (Exhibit A)

Blowout Road Corridor

- Beginning at the junction of Forest Road 10 (Blowout Road) and Highway 22, west along Forest Road 10 for approximately 5 miles. The affected area is 200 feet from the edge of both sides of Forest Road 10. See attached map (Exhibit B)

Suspension Bridge Trail #3426

- Beginning at the parking lot located adjacent to Forest Road 130; within the parking lot and within 200 feet from either side of Trail #3426 for its entire length. See attached map (Exhibit B)

Little North Santiam Trail (East) #3338

- The area within a ¼ mile radius from the parking area at the Little North Santiam Trailhead (East) (#3338). See attached map (Exhibit C)

Cleator Bend Area

- The area within a 200 foot radius from the bridge on Forest Road 2231. See attached map, (Exhibit D)
