Dear Prospective Offeror:

On 08/05/2015, at 02:00 PM, sealed offers will be opened in the Allegheny National Forest Supervisor's Office, 4 Farm Colony Drive, Warren, PA 16365 for the SRSP South Westline Stewardship Contract. The timber harvest units are located in Warrant 4916; Hamilton Township; Warrants 3087 and 3092; Wetmore Township; Warrants 3086 and 3091; Hamlin Township; McKean County; Pennsylvania. Timber Sale Contract 2400-13T will be used. The termination date for this sale is 6/30/2018.

There are 2.5 miles (3.97 kilometers) of specified road reconstruction. A specified road construction cost of \$119,725.00 has been allowed in the appraisal for this work.

The estimated quantities in this contract have been determined prior to felling. The total estimated quantity for timber removal on this sale is 2,171 CCF. Mandatory service work consists of 2 projects which include: manual site preparation and manual non-native invasive plant treatment. The Forest Service encourages potential offerors to make their own inspection and estimate prior to offer submission.
