Temporary Fire Restrictions

Pursuant to 36CFR 261.50(b), the following acts are prohibited on the Siuslaw National Forest:

- (a) Building, maintaining, attending or using a campfire, fire, or stove fire including a charcoal fire when not in a pre-installed fire enclosure at a maintained USFS site listed in Attachment A**

§36 CFR 261.52(a)

**Exceptions:**

- a. The use of a pressurized liquid gas stove, pressurized liquid gas fire, pressurized liquid gas lantern or an enclosed solid fuel fire that utilizes a wick to distribute a flame are exempt from this order.**

- (b) Smoking except within an enclosed vehicle or building, a developed recreation site or while in an area of at least three feet in diameter that is barren or cleared of all flammable material.**

§36 CFR 261.52(d)

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this Order:

- 1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.**
- 2. Any Federal, State or local officer, or member of an organized rescue or fire fighting force while in the performance of an official duty.**
- 3. Persons building, maintaining, attending or using a campfire within a designated sand camping area on the ODNRA or Sand Lake Recreation area dispersed camping**

**4. Persons using or maintaining portable cooking stoves using liquefied or bottled fuel.**

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A and other published Forest Orders in existence on the Siuslaw National Forest.

This order will be effective at 0001 am/pm on 7 August 2015 and will remain in effect for six months or until rescinded.
