FIRE and SMOKING Restrictions

Pursuant 16 U.S.C. 551 and to 36 CFR 261.50 (a) and (b), the following acts are prohibited on the Gifford Pinchot National Forest.

Prohibition:

- 1) Building, maintaining, attending, or using a fire, campfire or charcoal fire, is prohibited except in provided metal campfire rings or grills in developed recreational sites described in Exhibit A. 36 CFR 261.52 (a) *Exception: The use of pressurized liquid or gas fueled stoves or lanterns are permitted.*

Definitions: **Campfire** means a fire, not within any building, mobile home or living accommodation mounted on a motor vehicle, which is used for cooking, personal warmth, lighting, ceremonial or esthetic purposes. **Fire** includes campfire. **Stove fire** means a campfire built inside an enclosed stove or grill, a portable brazier, or a pressurized liquid or gas stove, including a space-heating device including wood or charcoal fires.

- 2) Smoking is prohibited. 36 CFR 261.52 (c) *Exception within an enclosed vehicle or building or a developed recreation sites.*
- 3) Using any type of motorized vehicle (Motor Cycles, ATV, OHV etc..) on National Forest System Trails is prohibited. 36 CFR 261.55 (b)

Exemptions:

Pursuant to 36 CFR, Sec. 261.50 (e), the following persons are exempt from this order:

- 1 Any Federal, State, County or Forest officer, or member of an organized rescue or firefighting force in the performance of an official duty.
- 2 Persons with a permit specifically authorizing the otherwise prohibited act or omission.
- 3 Persons building, maintaining, attending or using a campfire or charcoal fire in a **Developed Recreational Site** listed on "Exhibit A".

Area Description:

This area affects National Forest Systems lands within the exterior boundary of the Gifford Pinchot National Forest including Mt St Helens National Volcanic Monument.

IMPLEMENTATION:

- 1 This Order will be in effect on July 03, 2015 at 0001 hours and shall remain in effect until December 31, 2015 at 0800 hours or until rescinded, whichever occurs first.
- 2 This Order rescinds, replaces and supersedes any previous Orders prohibiting the same acts.
