**SPECIAL ORDER OF FOREST SUPERVISOR
MYSTIC and HELL CANYON RANGER DISTRICTS**

PARKING

Pursuant to 16 United States Code (U.S.C.) § 551 and 36 Code of Federal Regulations (C.F.R.) 261.50 (a), the following acts are prohibited on those National Forest System lands within the Mystic and Hell Canyon Ranger Districts, Black Hills National Forest shown on the map attached as Exhibit A (the "Restricted Areas").

Restricted Area 1 is further described as those portions of Black Hills Meridian in Township 1 North, Range 2 East, Section 27, 28, 32, 33, 34 & 35 and in Township 1 South, Range 2 East, Sections 2, 3, 4, 10 & 11 as designated on the attached map.

Restricted Area 2 is described as the Main parking area located in Township 1 North, Range 2 East in the west half of Section 33 as shown on the attached map.

Restricted Area 3 is described as the Overflow parking area located in Township 1 South, Range 2 East in the Northeast quarter of the Northwest quarter of Section 4 and in the Southwest quarter of the Northeast quarter of Section 32 as shown on the attached map.

The purpose of the Order is to protect natural resources from being damaged.

PROHIBITIONS:

1. Parking or leaving a vehicle in Restricted Area 1 except when the vehicle is parked in Restricted Area 2 or Restricted Area 3. 7 C.F.R. § 261.53 (f)
2. Parking or leaving a vehicle in violation of posted instructions in Restricted Area 2 and Restricted Area 3. 36 C.F.R. § 261.58(g)

EXEMPTIONS:

Pursuant to 36 C.F.R. § 261.50 (e), the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

This order will be in effect from the date it is signed, and continue through October 31, 2015, or until rescinded.

This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the areas (and/or roads or trails) covered by this Order.

Violation of this prohibition is punishable as a Class B misdemeanor, by a fine of not more than \$5,000.00 for an individual, or \$10,000.00 for an organization or imprisonment for not more than six (6) months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559 and 3571
