FOREST ORDER No. 06-10-24-15-11

EMERGENCY ROAD AND AREA CLOSURE FOR PUBLIC HEALTH AND SAFETY

Pursuant to 36 CFR § 261.50(a) and (b), the following act is prohibited within the Gold Beach Ranger District as described below and as depicted in map attached as Exhibit A, located within the Rogue River Siskiyou National Forest from August 7, 2015 until October 31, 2015, unless sooner rescinded.

- 1) Being within the described area closed for public health and safety: [36 CFR § 261.53(e)]

CLOSURE AREA

Beginning at the southwest section corner of section 13, T.38S, R.13W;

- **thence** easterly to the southeast section corner of section 13;
- **thence** northerly to the southwest section corner of section 6, T.38S, R.12W;
- **thence** proceeding easterly to the southeast section corner of section 1, T.38S, R.12W;
- **thence** northerly to the southwest section corner of section 6, T.38S, R.11W;
- **thence** proceeding easterly to the southeast section corner of section 5, T.38S, R.11W;
- **thence** northerly to the northeast section corner of section 5, T.37S, R.11W;
- **thence** westerly to the southeast section corner of section 31, T.36S, R.11W;
- **thence** northerly to the northeast section corner of section 19, T.36S, R.11W;
- **thence** westerly to the northwest section corner of section 21, T.36S, R.12W;
- **thence** southerly to the southwest section corner of section 33, T.36S, R.12W;
- **thence** westerly to the northwest section corner of section 5, T.37S, R.12W;
- **thence** southerly to the northeast section corner of section 7, T.37S, R.12W;
- **thence** westerly to the northwest section corner of section 12, T.37S, R.13W;
- **thence** southerly to the southwest section corner of section 13, T.38S, R.13W; the point of beginning.

ROADS CLOSED

- 2) Being closed for public health and safety. [36 CFR § 261.53(e)]
- A. Road 1376 and all of its tributary roads, from its junction with the 1917 road proceeding north to its junction with the 3680 road.
  - B. Road 1407 and all of its tributary roads, from its junction with the 210 and 230 roads (the "Stack Yards") east to its junction with the 1376 road.
  - C. Road 3680 and all of its tributary roads, from its junction with the 3318 to its end.

Pursuant to 36 CFR § 261.50 (e), the following persons are exempt from this Order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.

This prohibition is in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

A violation of this prohibition is punishable by a fine of not more than \$5000.00 for an individual or \$10,000.00 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559 and 3571.

This Order is effective immediately.


