FOREST ORDER No. 06-10-24-15-13

EMERGENCY AREA CLOSURE FOR PUBLIC HEALTH AND SAFETY

Pursuant to 36 CFR § 261.50(a) and (b), the following act is prohibited within the High Cascades Ranger District as described below and as depicted in map attached as Exhibit A, located within the Rogue River Siskiyou National Forest from August 14, 2015 until October 31, 2015, unless sooner rescinded.

- 1) Being in an area closed for public health and safety. [36 CFR § 261.52(e)]

From the four way intersection of Forest roads 6530,6560, and State Highway 230 (T.29S, R4E, Section 3) following the 6560 road north to the Rogue River - Siskiyou NF(RRSNF), Umpqua NF (UNF) Boundary (T.28S, R.4E, Section 3, T28S, R4E, Sections 34 and 27). Then Following the RRSNF-UNF Boundary to Highway 230 (T.28S, R4E, Sections 27, 26, 24, T.28S, R.5E, Sections 18, 17, 20, 21, 22, 27, 26). Then following Highway 230 to close the loop. All roads and area inside this boundary, including roads that make up the boundary are closed.

Pursuant to 36 CFR § 261.50 (e), the following persons are exempt from this Order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Persons who are using National Forest land strictly for direct and lawful access to or from private property.

This prohibition is in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

A violation of this prohibition is punishable by a fine of not more than \$5000.00 for an individual or \$10,000.00 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559 and 3571.

This Order is effective immediately.


