


Scarification and seeding of landings, temporary roads, and skid trails is required, C6.6#.

Purchaser and Forest Service will agree to the design, construction, maintenance, closure, and obliteration of all Temporary Roads. Temporary Roads and Landings are subject to the conditions in C5.1# (Option 1).

Landings on or adjacent to Roads 1700, 1705, 1720, 1730, 1735, and 1800 will have slash pulled within 150 feet uphill of landings and within 50 feet below or on flat ground adjacent to landings. Slash that is pulled to the landing shall be piled with other landing slash and covered, C6.74#.

Wildlife reserve trees may be present in all cutting units, C2.3#, C6.32#.

Units in Subdivision 1 are posted on the ground as "Upper Finney Thin". Units in Subdivision 2 are posted on the ground as "Chute Thin".
