**ORDER NO. 01-17-01-15-008**

**ORDER**

Pursuant to Title 36 Code of Federal Regulations (CFR) 261.50(b) the following acts are prohibited on portions of the Salmon River Ranger District, as described in this order and shown on the attached map, within the Nez Perce-Clearwater National Forests. These restrictions are in addition to those general prohibitions in Title 36 CFR, Part 261, Subpart A, become **effective IMMEDIATELY and shall remain in effect until rescinded.**

1. **Going into or being upon an area.** 36 CFR 261.52(e)

**AREA DESCRIPTION:** **Beginning** at the mouth of French Creek in section 14, T24N, R3E, Boise Meridian; **then** west along the Salmon River to the Forest Service Boundary; **then** north along the Forest Service boundary to the Township line between 25N and 26N; **then** east along the township line to the junction of FS Road 394 and FS Road 221; **then** south to the mouth of French Creek the **point of beginning.**

2. **Being on the road.** 36 CFR 261.54(e). **Forest Road 394.**
3. **Being on a trail.** 36 CFR 261.55(a). **Forest Trail 643.**  
South of the township line from the junction of FS Road 394 and FS Road 221.


**EXEMPTIONS**

Pursuant to Title 36 CFR 261.50(e), the following persons are exempt:

1. Persons with specific written authorization for the otherwise prohibited act or omission.
2. Any Federal, State or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in the performance of an official duty.

**RATIONALE:** These restrictions are promulgated to provide for **Public Safety** during Wildfire Activity.


**PENALTY:** Violation of this order is prohibited by provisions of the regulations cited, and under USC 551 and 18 USC 3559 and 3571. Any violation is subject to punishment by a fine of not more than \$5000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both.

**NOTIFICATION:** A copy of this order shall be posted in the Forest Supervisor's Office and each District Ranger's office and other appropriate locations as prescribed under Title 36 CFR 261.51.
