**Elevenmile Fire
Emergency Trail Closure**

PROHIBITIONS: Pursuant to 36 CFR 261.50 (b), the following act is prohibited on the area, roads and trails as described in this order, all within the Middle Fork Ranger District, Salmon-Challis National Forest until further notice:

1. Being on a trail described below that is posted as closed. **36 CFR 261.55(a)**

EXEMPTIONS: Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

TRAIL CLOSURE DESCRIBED:

Forest Trail # 4104 Warm Springs Trail from its junction with NFST # 4119 (T15N, R16E, S29 BM) south easterly to the Wilderness Boundary.

Forest Trail # 4114 East Mayfield- Yankee Trail from its junction with NFST # 4116 (T14N, R15E, S9 BM) south easterly to the Wilderness Boundary.

Forest Trail # 4119 Trapper Creek Trail from its junction with NFST # 4104 (T15N, R16E, S29 BM) south westerly to its junction with NFST # 4114 (T14N, R16E, S31 BM).

Forest Trail # 4120 Kerr Creek Trail from its beginning (T15N, R16E, S27 BM) south westerly to its junction with NFST # 4104 (T15N, R16E, S33 BM).

The above-described trails are located within the proclaimed and administrative boundaries of the Middle Fork Ranger District, Salmon-Challis National Forest, Custer County, Idaho.

PURPOSE:

These closures are necessary to provide for public safety and protection of forest visitors from wildland fire hazards associated with the Elevenmile Fire.

IMPLEMENTATION:


1. This Order will be in effect when signed and shall remain in effect until further notice.
2. A map identifying the closure area is attached and made part of this Order.
3. Any violation of this prohibition is punishable by a fine of not more than \$5,000.00 for an individual or \$10,000 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571 (b)(6), Title 18 USC 3581 (b)(7)].
4. This Order supersedes any previous orders prohibiting the same acts covered by this Order in the above-described area.
