## PROHIBITIONS

### **FOREST SUPERVISOR ORDER NO. 08-13-00-14-07 Deer Hunting Season Camping Closure**

Pursuant to the provisions of 16 U.S.C., Section 551 and Title 36 C.F.R. Part 261, Subpart B, the following act is prohibited for the protection of public health, safety, and natural resources.

**AFFECTED AREA:** All National Forests and Grasslands in Texas (NFGT) lands, including NFGT Wildlife Management Areas (WMAs), except for the Lyndon B. Johnson (LBJ) National Grasslands in Wise and Montague Counties. See attached maps.

**EFFECTIVE DATES:** September 26, 2014 through September 25, 2019 or until rescinded.

**PROHIBITED ACT:** **Camping is prohibited in the Affected Area from September 26 through January 8 of each year. This prohibition does not apply in designated campgrounds, designated hunt camps or designated camp sites which are shown on the attached maps. 36 C.F.R § 261.58(e)**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

This prohibition is in addition to the General Prohibitions in 36 C.F.R. Part 261, Subpart A.




# Angelina National Forest

Ladonia Unit





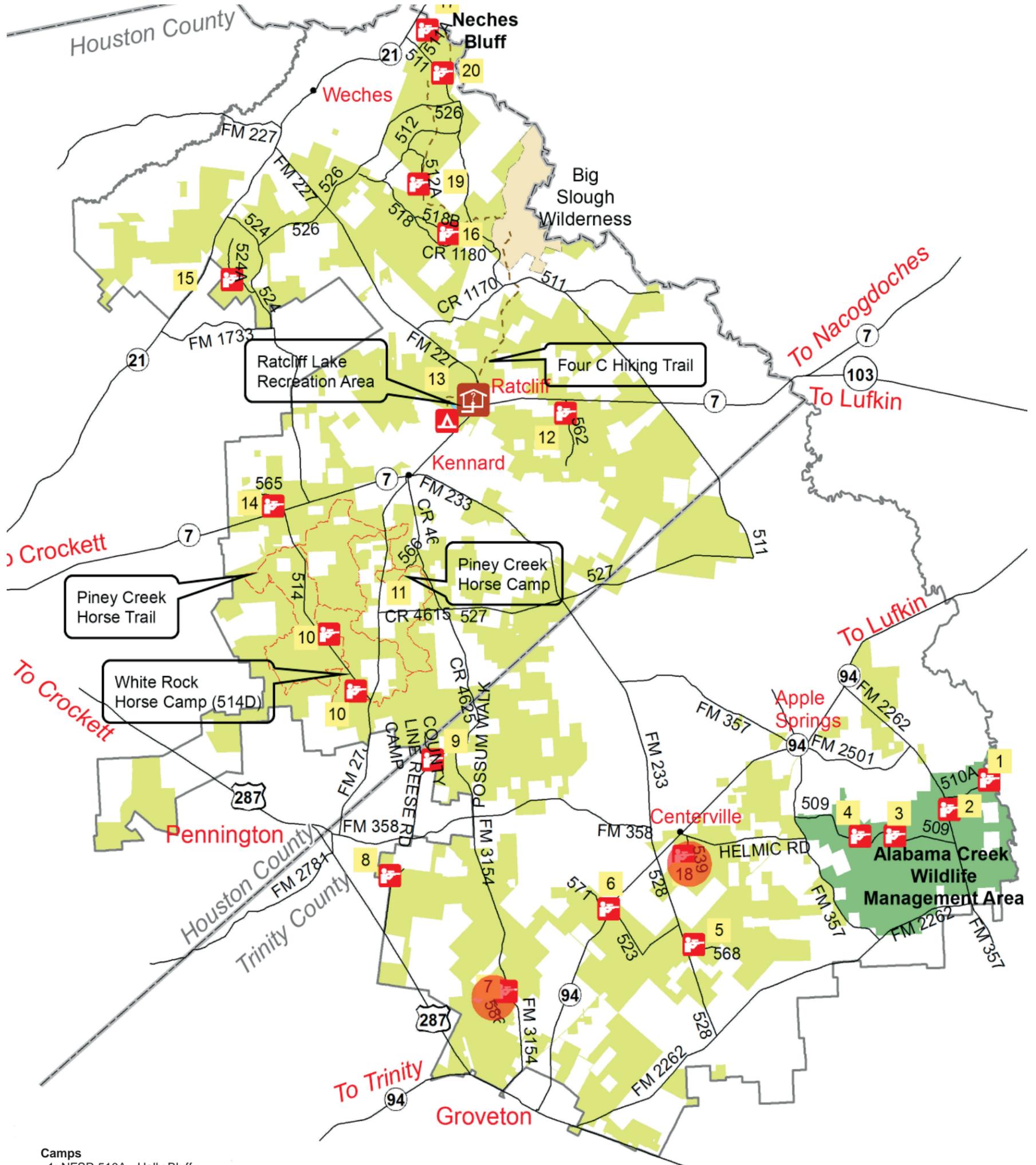


