**Potential Bidders – Blueberry West Timber Sale
Motor Vehicle Use – CFR 212.51**

For the period of **11/10/2009 through 12/10/2009**, you are authorized to use an ATV (or other vehicle 50” or less in width at the widest point on the vehicle) on those roads (system and temporary) shown on the attached Sale Area Map and table from Special Provision CT 5.12# of the Sample Contract. FR 2213 is open to all vehicles per the Ottawa National Forest MVUM. FR 2200 and 2210 are Houghton County jurisdiction roads.

As has been the case for some time now, cross country use of an ATV is not permitted. In addition, per CFR 261.12d, the following is also prohibited: damaging and leaving in a damaged condition any such road, trail, or segment thereof. Many of the roads in this Sale Area are scheduled for reconstruction or pre-haul maintenance activities through the timber sale contract due to the current condition of the road. Please use your judgment when determining if you can travel the road without causing further resource damage.

You must have this authorization in your possession while in the Blueberry West Timber Sale area.
