***ROAD CLOSURE  
(For Public Safety)***

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50(b) the following act is prohibited on the road described in this order, all within the Idaho City Ranger District, Boise National Forest. This Order will be in effect upon signing and will remain in effect until further notice.

1. Being on the road. **36 CFR 261.54(e)**.

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with a special use authorization (Timber Sale Contract) or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in the performance of an official duty.
4. Motorized vehicles 50 inches or less in width, non-motorized vehicles and pedestrians between Friday at 1800 hours (6:00 PM) and Monday at 0001 hours (12:01 AM).

**ROAD DESCRIBED:**

**National Forest System Road (NFSR) #327** beginning at the bridge crossing at Mores Creek to M.P. 6.5 (a.k.a. Rabbit Creek Summit), located within Township 6 North, Range 6 East, Sections 28-30, and 33-34 , and Township 5 North, Range 6 East, Sections 3 and 4, Boise Meridian.

The above described road is within the Idaho City Ranger District, Boise National Forest, Boise County, Idaho.

**PURPOSE:**

The road described is closed to all motorized vehicles and pedestrians between Monday – Friday to provide for public health and safety. Helicopter logging operations will be operating Monday – Friday 0500-1800. Operations include log truck traffic, service vehicle traffic and helicopter logging. Helicopter landing locations are located in close

proximity to NFSR #327 and the log truck traffic would make it dangerous to allow for public access during the weekday. The road described is closed to motorized vehicles over 50 inches in width Monday – Sunday (all week) to provide for safety to oversnow vehicle operators due to the limited width of the plowed road.

**IMPLEMENTATION:**


1. This Order will be in effect when signed and will remain in effect until further notice.
2. A map identifying the road closure is attached and made part of this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000.00 for an individual, or \$10,000.00 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581 (b)(7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the areas (and/or roads, trails) covered by this Order.

Assessment of Need and Enforcement Plan  
 Idaho City Ranger District – Boise National Forest  
 Order #0402-03-26

1. Background. A contract has been awarded to Columbia Helicopters for timber removal and associated slash treatment on the Mores South Helicopter Stewardship project, Solicitation AG-82B1-S-09-0086, on the Idaho City Ranger District. The project area is located on National Forest System Road (NFSR) # 327 which is located approximately 3 miles west of Idaho City, ID. Logging activity is expected to start on December 22<sup>nd</sup>, 2009 and continue until weather shuts down operations. The closure to all traffic will begin between Monday at 0001 hours (12:01 AM) and Friday at 1800 hours (6:00 PM) each week starting on December 28, 2009, and will remain closed Monday through Friday (as specified above) until further notice. To provide for public safety, motorized vehicles over 50 inches will be prohibited on NFSR #327 on weekends.

2. Intent of Subpart B order. This temporary road closure is for all motorized access and pedestrians to promote public safety during logging operations.

3. Enforcement Plan. On ground signing and maintenance of signs at the bridge on Mores Creek and NFSR #327 to advise the public of temporary road closure during logging operations. On site FS administrative personnel will make compliance contacts as needed.
