# General Wilderness Permit Reservation Instructions

November 2010  
Please Recycle

Apply from six-months in advance, up until 2 days before trip entry date.

Submit application by mail, fax or phone. This form can not be used for the Mt Whitney Lottery.

**Step 1. Fill out application:** Please be sure application is accurate and complete before you submit. See below for more terms and information.

**Step 2. Calculate fee:** Enter group size and calculate fee. Reservation fee is \$5.00 / person, except if you enter the "Whitney Zone" at any point during your trip, then the fee is \$15.00 / person instead of \$5.00/person.

**Step 3. Payment:** Applications must include payment for reservation fee (US Funds only). Payment returned if no reservation is made. Pay by VISA or MasterCard; check; or money order payable to: **USDA Forest Service**

**Step 4. Submit to:** Wilderness Reservation Office, 351 Pacu Lane, Suite 200, Bishop, CA 93514; Fax (760) 873-2484; Phone (760) 873-2483.

**Step 5. Reservation Confirmation:** Application requests are processed in order received. Reservation is based on space available for entry date requested. Response is by mail unless trip is imminent.

**Mt Whitney:** Use this form if you missed the lottery and are submitting an application in April or later, **or** for other alternate trails to Mt Whitney.

Use this application for the following **overnight** trips to Mt Whitney:

- Trip that **ENDS** on the Mt. Whitney Trail, but begins on any other Inyo National Forest trail (such as Shepherd Pass, Kearsarge Pass, North Fork of Lone Pine Creek, etc). Apply as you would for "Other Trails" and use "Trail Crest" as exit trail.
- North Fork Lone Pine Creek access to the Mountaineer's Route, East Face/ Buttress.

Mt. Whitney permits must be picked up at Eastern Sierra InterAgency Visitor Center.

Day hike permit cannot be used to begin or end an overnight trip. No consecutive day hikes.

North Fork of Lone Pine Day Hike is included in Mt .Whitney Day Use Quota.

Reservation fee is \$15.00 per person if at any point during trip you enter the Mt. Whitney zone.

For available dates and when to apply for remaining space for the Main Mt Whitney trail, refer to the Inyo National Forest website or phone the Wilderness Reservation Office after April 1st.

## Terms and Conditions: For Golden Trout, John Muir, Ansel Adams, and Hoover Wilderness Areas

Permits are required year round for overnight wilderness trips and for day use into the Mt. Whitney zone. Quota season is from May 1<sup>st</sup> through November 1<sup>st</sup>, except Cottonwood Pass quota applies from the last Friday in June to September 15<sup>th</sup>. During non-quota season use self-issue permits, located at Inyo National Forest Visitor Centers.

All members of your party **must enter the wilderness** on the **entry date** and **entry trail** specified on the permit. No exceptions.

Group size cannot exceed 15 people. Large groups can not exceed 15 people even if they are on separate permits.

Submit only one application for each planned trip (i.e. for one trip in June and another trip in August, send one application for each trip).

Sending duplicate applications may result in multiple reservations with non-refundable charges. Once a reservation has been issued, there are no refunds. Reservations are not transferable to other parties or to future years. Reservations are not for re-sale.

If there is space available you can: change your date of entry or trailhead for a \$10 Change of Reservation Processing Fee or add to your party size by paying the additional \$5 per person (\$15 per person for the Mt. Whitney Zone) reservation fee. For space availability, refer to our website or contact the Wilderness Permit and Reservation Office.

You **must confirm or pick up your permit** before the deadline, or your reserved permit will be canceled and will be re-issued to other parties on a walk-in basis.

Day hike confirmation deadline is noon on day before entry. Overnight trip confirmation deadline is 10 a.m. on your entry date.

Pick up your reserved wilderness permit at an Inyo National Forest Visitor Center, in person up to two days before the entry date of your trip. At that time you will receive up to date site-specific information regarding bear canister requirements, bighorn sheep protection areas, camping, campfire, and other specific regulations.
